
# 2.15. Reflections on Mind, Consciousness and Matter.






The "PSI-GENERATION" factor.

The progressive development of any system is inseparable from the same progressive development of all elements of the system and is subject to the fundamental laws of the development of matter. In the event of a violation of the development cycle of an element or subsystem, the entire system is at risk.

The laws of the development of Mind and Consciousness are inseparable from these fundamental laws, as a part cannot conflict with the whole without jeopardizing the very fact of the existence of the whole. Therefore, when comprehending the laws of the Development of Mind and Consciousness, it is necessary to take into *account the physics of processes* at the level of the macrocosm and microcosm. And let's not forget that Consciousness, Mind and Matter are inseparable parts of a single whole, as the "triune truth". These laws are general and characterize the whole variety of processes involved. This means that both Consciousness and Mind are not some idealistically enthusiastic categories, but, on the contrary, are categories of Matter, just like Matter, in its development can reach the level of Mind. The development of Consciousness and Mind is not something that can be described with the help of religious dogmas, esoteric speculation, or the fascinating psychological delights of Dr. Freud and his talented followers. Followers, of course, tried their best to outdo grandfather, but for the most part they did not stray very far from him. Especially noteworthy in this regard is the "wonderful" theory of behaviorism, put forward and actively promoted by its American followers, led by its founder John Watson. According to this theory, all human behavior is easily explained by the same mechanisms that shape behavior in animals, and in fact by reflexes that are little distinguishable from the reflexes of Dr. Pavlov's unfortunate wards.





The philosophical basis of behaviorism is John Locke's concept of the birth of man from a blank sheet of Tabula rasa and Thomas Hobbes's nonrecognition of the existence of a thinking substance.

John Brodes Watson proposed a scheme explaining the behavior of humans and other living beings: S-->R a stimulus causes a reaction. The stimulus and

reaction were measurable, so this approach did not cause much doubt. Watson believed that with the right approach, it would be possible to completely predict the behavior, control and shape people of the necessary professions by changing the environment. The mechanism of these influences was learning through classical conditioning, studied in detail on animals by Pavlov.

Human behavior has been studied by these "wonderful people" often on animals, and therefore it should not be surprising that the methods of achieving their goals, Americans, often lie in line with the same animal instincts.

But all this is not so interesting anymore, and therefore we will leave them to themselves, since everyone gets what he deserves. America, along with the entire Western Civilization, has fully deserved its "bright future" (which is already coming).

We are now interested in something completely different.

As applied to a human being, the development of the Mind implies the necessity to give oneself the labor to set tasks for the Mind that go beyond the limits of ordinary everyday thinking, not to be afraid to break stereotypes and use intuition, imagination and fantasy as integral tools of one's own development, for the Mind in its potential is as limitless as the Cosmos itself is limitless.

Therefore, this article is an attempt to understand at least a small part of all this infinity. But since in this article we will allow ourselves to apply both intuition and imagination, then it should be perceived not as a ready-made and approved by someone, but as **a hypothesis or a certain probability**. And even though it may seem controversial and provocative in some ways, but still, it is an attempt to



understand and comprehend those aspects of new knowledge, those questions where we do not have ready-made answers and solutions. After all, no book will ever have answers to all the questions, and it is necessary to put them in front of you and look for answers to them! Otherwise, feeding only on ready-made knowledge, the Mind may go into hibernation.

What is human consciousness and consciousness in general, if it is permissible to put it that way. This question is the most complicated and represents, perhaps, one of the main mysteries of the Universe. Let's try to reflect, and maybe we will be able to get at least a little closer to solving and understanding this issue.

Again, when considering the laws of the development of Consciousness and Mind, we cannot separate them from the physics of all processes of the development of Matter, both at the level of the macrocosm and microcosm. **And Consciousness, Mind and Matter are parts of an indivisible whole, it is unlawful to separate them from one another.** Without this understanding, we will have no choice but to repeat the ingrained misconceptions of all scientific, religious and esoteric thought on this issue. But for all the 18,000 years of intervention, none of these directions has come close to the truth, and does not explain the essence of these concepts.

Matter develops on the basis of strictly defined physical laws, and this is not disputed by anyone. But human thought did not refer Consciousness and Mind to Matter, as such, in any way, explaining it with anything - religious postulates, economic laws, class struggle, psychology, instincts, finally. But not with Matter.

If one or another concept does not give a consistent answer to the questions posed, but, on the contrary, only thickens the fog around them even more, then such a concept cannot be considered true. For it (the concept), then the concept of "assumption" may be applicable. And nothing more. The assumption may be an incentive for further search for the truth, but if the search has not been successful, the assumption cannot become the basis for the formation of the concept, but should be rejected as not confirmed.

Yet, nevertheless, part of the concepts, at certain rhetorical stages, declared a complete comprehension of the truth about Consciousness and Mind. And this truth was postulated as immutable.


We will not dive into the analysis of these concepts now, there is no sense in this, and if anyone has an increased interest in these issues, then there are plenty of all kinds of works on these issues, large and small.



In this article we will try to find common ground in the works of Russian Scientists N.V. Levashov, A.M. Khatybov, A.A. Luchin and others, specifically in relation to issues of Consciousness and Mind. And also consider, at a level accessible to us, the role of the "SvetL" Programs in these fundamental issues. And, although in this article there will be both free author's digressions and assumptions (so far it is

"assumptions") which may seem controversial, but we believe that such deviations and assumptions have a right to exist, and moreover are necessary. They are necessary, since any knowledge must be comprehended and analyzed by one's own Mind, because without such comprehension, the development of Mind is impossible.

So, let's start "from the beginning".



Consciousness at the non-inertial level has a cellular structure built on a dodecahedral basis. The cubic construction imposed during the intervention blocked most of the connections, forming artificial restrictions and making progressive, evolutionary development impossible. Consciousness, which has the basis of a cubic structure, as well as in the structure of DNA, HAVING RESTRICTIONS ON INPUT-OUTPUT

BLOCKS, did not allow the cells to be combined into a single structure. This fact most directly contributed to the formation of a false "I" based on imposed societal ideas. *A person is not what he really is, but what roles he is forced to play in his life.* And there could be many such roles, while each of them sought to develop into an "I", which is false for a human being, since it had nothing to do with his personality or his Essence. And society imposed ideas on a human on how to play these roles in order to achieve success. Thus, the EGO developed, since the pursuit of success, in its understanding by society, is impossible without the EGO. For the true Personality, for the true individuality of a Man, for the Essence with all its experience of incarnations, these societal ideas about success have no value. On the other hand, religious and esoteric ideas put the destruction of the EGO at the forefront, by renouncing the "I". But here there was an almost imperceptible, but extremely significant substitution, since it was already necessary to give up one's true self, one's individuality. At the same time, it is assumed that all the experience and memory gained was eventually transferred to the higher structures, the egregors of these religions. As a result, there was inevitably a blurring of personality and, as a consequence, the impossibility of its evolutionary development.

The consequence of the cubic construction was the impossibility of realizing the true world order, the impossibility of combining the individual consciousness with the consciousness of structures that make up a single structure of space and include as constituent elements the consciousness of cells, organs, consciousness of the physical body on the one hand, and consciousness of the planetary mind (LOGOS (EARTH CONTROL SYSTEM)), consciousness of structures of the Cosmic Level, on the other hand.


# perfection of harmony only of the non-inertial state of energies and its Mind, becoming in the final the hypostasis of the Universal Mind!"

The dodecahedral construction of consciousness structures (consciousness cells) ensures the interaction of individual consciousness, the consciousness of Man as a personality, with other levels of consciousness structures. Thus, initially, mobile, dynamic structures are formed that ensure the full interaction of Control Systems at each level, without which the evolutionary development of both Man and the Mind of the Earth, as well as Planetary and Galactic civilization clusters, is impossible. Further, the following should be taken into account: it is necessary to understand through the principles of non-Euclidean geometry as the main basis for constructing space. The dodecahedral structure is a carrier, but it is not the main dominant form in relation to the unified construction of the space of the Universe. Here it is necessary to consider the Mobius Strip - the embodiment of the law of interconnected spaces (we will consider the meaning of the Mobius strip in more detail later). The current knowledge and ideas of a Man do not allow adequate representation and interaction with this structure. In addition to the dodecahedral structure, the levels of the Earth's atmosphere are also associated with the formation of spatial relationships based on non-Euclidean spaces. Their harmony in this basis of representations is the most important factor for the Universe. The cell is also the Universe for certain levels of space. Consequently, an integral part of Man at the inertial and non-inertial levels is an innumerable set of Universes existing at other levels of space. On the other hand, Man himself is a microscopic link in the scale of our universe. And there are also countless such Universes. At the most understandable level for a Person, taking into account the current level of the Brain octave, it can be represented as two serpentine ribbons, located one in the other and continuously interacting. By presenting such a construction, we get the similarity of the DNA helix, which is a representation of the shape of space at all its levels. Our understanding of the shape of the DNA helix is incomplete due to the inability to see (taking into account the tools available today) its complete and true construction. Now (for now) we have a closed 4 DNA codon and the construction of DNA on the principle of a benzene ring, i.e., based on k-structures, while in their correct, true construction, DNA binding nodes have a dodecahedral construction.

### Benzene ring.




Benzene model of the dodecahedron

The development of consciousness is impossible without taking into account and processing the experience gained. Experience is a category of memory. But a leap in the development of consciousness can occur

only when memory carries information and not as some kind of knowledge in general, but **only if this knowledge has become a personal experience of a Man** (or any carrier of consciousness). Only then does enlightenment by knowledge occur, knowledge becomes a personal experience, this experience is accepted, absorbed by the structures of consciousness and a qualitative leap occurs, which makes it possible to form matters with new properties and qualities. Here again it is necessary to recall the above example of Human interaction with structures that ensure the existence of religions. In the process of development, a person, receiving life experience, develops additional bodies, i.e., matter. Energy is the basic quality of matter. Accordingly, abandoning personal, individual consciousness in favor of various Gods and Deities, a person transfers his own energy to these structures, i.e., provides their energy saturation (nutrition) at the expense of himself, receiving in return the illusion of acquiring new qualities, or the illusion of the existence of paradise on the "other side". At the same time, in case of getting to Heaven, the transfer takes place voluntarily, when getting to Hell - forcibly. Although these categories are imposed by the interventionist civilization.


## Space as a characteristic of the structures of consciousness.

Considering this issue, first of all, it is necessary to take into account the relationship of the life support fields of the IFNS (information field of the neutrino space) and the IFPS (information field of the proton space). Each of these fields is a spatial structure. Let's take into account that the IFPS does not exceed 72 octaves, and the IFNS is an octave from 72 and above. Everything that is memory is located in the IFNS. Accordingly, when talking about consciousness, we can talk about IFNS, since consciousness is inseparable from memory and cannot be formed without memory. The physical (dense) human body depends entirely on the qualitative characteristics of additional bodies, or rather, the characteristics of the substances they consist of. Cellular memory can also exist only in neutrino space, and in relation to consciousness at the cellular level, all of the above is true. **Brain-cell and Brain-organ communication is carried out at the level of additional cell bodies and organs, and violations at the level of the dense physical body are a consequence of these violations.** 

When constructing structures (cells) of consciousness on a dodecahedral basis (at all levels), such connections are quite stable, which ensures stable operation of the system as a whole and

dramatically increases the life of the biostructure. The cubic construction has a significantly smaller number of communication nodes, which cannot provide stability. The result is diseases and aging of the physical body.

At the cellular level, DNA is responsible for providing communication with the brain. Recall that **at present, the 4th DNA codon is not yet active** and this condition persisted throughout the intervention. The beginning of the disclosure of the 4th codon will ensure a gradual increase in the Brain octave and its restructuring to a dodecahedral basis (more precisely, the formation of dodecahedral structures of the energy grid is primary here and there can be no question of any increase in the octaves of the brain until an energy grid is formed that can pass a charge with a higher density at higher octaves, relative to the current state). The consequence will be a change in the spatial characteristics of the human body in relation to all levels of space.



But space is a measure of the reaction time on an object. And each object has its own space. (A.M. Khatybov).

This means that the

question of Consciousness is also in close relationship with such a concept as "time". Any change in the physical characteristics of an object leads to a change in spatial characteristics, and this leads to the influence of the object on higher-level spaces, since all objects are in a certain relationship with each other, which means that spaces are in the same relationship. From this it becomes clear that the question of the development of Consciousness and Mind of an individual or any element of a Subsystem cannot be considered in isolation from the influence it exerts on the System, and the System



cannot develop without a similar development of Subsystems, but within the framework of the corresponding cycle.

And therefore, the Earth as a System cannot move to a higher level of its development until its transition to a higher level is made by man, **at least by those who integrate into a new Civilization**, and therefore will be its integral elements. Otherwise, it would result in a gross violation of all basic physical laws, which is simply impossible. From here it becomes clear the role played by both individual and social consciousness of man in the entire process of evolutionary development, both of Humanity and of the Earth.



The lesser, by definition, cannot control the greater. In practice, this happens, but the most striking manifestation of this situation is cancer. Cancer is a consequence of a violation of the cell-Brain connection. The cell as a unit of consciousness tries to impose its "will", its "idea of development" on the whole organism. The result is known. It happens in a similar way at the level of the Big Cosmos. Civilizations that have chosen a parasitic path of development are trying to impose their will on the entire universe and rebuild it in their image and likeness. The cases of the death of Universes unable to cope with the seizure and spread of parasitic civilizations are described by N.V. Levashov ("The Mirror of my Soul. Volume 2"). Accordingly, for Human consciousness, the presence of a Control System with a higher octave is a vital necessity from the point of view of the Control System itself. Otherwise, the existence of this System may be at risk. A person cannot have a complete and accurate idea of the true meaning and purpose of the existence of higher-level structures. As a consequence, an attempt to impose one's own will and one's own ideas about development goals on higher structures (systems) can lead to a "surgical operation" that manifests itself as a shutdown of the human Brain (of course, if "drug treatment" (control correction) does not help). This situation persists at all levels. Potentially, according to the level of his consciousness, even without the need to increase the Brain octave, a man is able to independently (by the power of thought) correct a diseased organ or system of the body, because for this organ or system, the Human Brain is a Control System. Accordingly, for a diseased organ, such an impact will be a controlling correction. Such correction, in the end, is for the benefit of the most diseased organ. If the case is started or the possibility of individual conscious correction is not accepted by a person, he runs to doctors who either perform a "peace enforcement operation" through drug treatment, in relation to the "rebellious" organ, or the operation "anti-terror" comes into force and part of the diseased organ (or the whole organ) is simply eliminated. But the decision on the need for such an impact is ultimately made by the person himself, as a Control System for this body. Therefore, for a person who considers himself the king of nature and the crown of creation, his highest evolutionary point, operation "anti-terror" can also be applied by the Earth's Control System, which should not surprise and upset him.


One of the most important manifestations of a man's consciousness, as his individuality, is will. In a situation where there is no resistance from the environment and the need to make informed decisions, often in spite of the current situation, there is no potential for development. By making a choice and making strong-willed efforts to solve the task, a man develops new substances and thereby increases his energy potential. That is, he acquires, develops what is called power in the everyday understanding. At the same time, being essentially a spatial structure and changing the characteristics of their own spatial structures, a man thereby changes the characteristics of the surrounding space. The decisive value is the starting point of the choice and the beginning of the action, i.e., the choice of the direction of the path. Although a person almost never imagines exactly what consequences his actions will lead to, but if he is deprived of the opportunity, based on his current level of development, to calculate the long-term consequences of his actions, then as a guide for decision-making, it is based on those concepts that are significant for him personally. And this is also a question of a person's individuality. For some, such guidelines are honor, conscience, a sense of duty to the Motherland or loved ones, for another, the desire for power, money, popularity. But in both cases, these concepts can be a stimulus to the application of volitional efforts, which, one way or another, will affect the evolutionary level of a person. At the same time, experience is always experience, and we can never know which way a person will go next. The chosen direction is not always final, and the opportunity to "wake up" is also almost always preserved. And then the result and experience gained on the basis of some motivational prerequisites can be used in the future, when they change.

An important point when considering the question of consciousness is the conceptual apparatus. It should be borne in mind that the current conceptual apparatus is largely imposed from the outside as a result of the intervention control system. The formation of the conceptual apparatus of man was carried out mainly through the imposition of religious and scientific fairy tales, presented as religious and scientific dogmas.



The first priority in the matter of religious dogmas were the concepts of good and evil. Despite the seeming indisputability of these concepts, it is impossible not to admit that they are built on the basis of a binary measurement system and dual logic. These concepts were indisputable for a person and were not questioned by human consciousness. Although, at the same time, it is obvious that these concepts cannot be perceived in isolation from the context of the imposed paradigm, or in an esoteric interpretation - within the framework of an established picture of the world. What was considered good or evil in one religion, or in relation to a group related to the world picture (one religion, one clan, one people, one ethnos or super-ethnos) could change its polarity in relation to another group. "Thou shalt not kill" is a law for one's own, but strangers, infidels, or Goyim can be killed, and even should be, because it pleases God. Similarly, the opposite - not to kill the enemy who attacked your land, not to protect your land is evil and is not subject to forgiveness. The same can be correlated with all other commandments in all religions. Proceeding from this, it is necessary to recognize that these concepts are not absolute priori. But man in his conscious activity has never gone beyond the laws imposed by dual logic and has not subjected them to analysis. In order to be able to do this, it is necessary to go beyond the limits set by the imposed paradigm. But any dissent was severely suppressed. And even when dissent made its way, it eventually turned into a new paradigm built on the same dual laws. The level of development of human consciousness simply did not give the opportunity to think and live differently. And there is no need for examples here, the whole human history is a confirmation of this.

Scientific dogmas in this regard are no different from religious ones. Only the formation of these dogmas acquired its fundamental importance at the final stages of intervention, mainly since the XIX century. Before that, even fragmentary scientific knowledge was the lot of the chosen. Later, when universal education was introduced everywhere, scientific dogmas became crucial in the formation of both public and individual consciousness. With the apparent expansion of the picture of the world, human consciousness became more and more enslaved. All the concepts that were put into consciousness in the process of forming a life paradigm, turned into a tightly soldered brick wall that obscured the horizon. No scientific discovery could shake the system, as it was broadcast by it. It would seem that scientific progress expands the horizons of knowledge, but in fact, it only narrows it, leading further away from the truth. But Man did not allow himself the trouble to analyze the basis of the conceptual apparatus, in what stands behind the words that form the basis of the scientific worldview. To date, science, in fact, does not have a clear explanation of its provisions. Any definition is nothing more than a set of words, behind which there are the same, unexplained concepts.



In order to find the true meaning of any scientific concept, it is necessary to have the possibility of its multicomponent analysis, consideration of all its aspects. But, again, a person has no opportunities for this, because consciousness **is built on dual logic**. Let us recall here the cubic and dodecahedral structure of lattices. The cubic structure has an extremely small number of connections, being in one node, we can move only in three directions. Let's remember that in our current reality we have three dimensions. But the true construction of the atomic lattice is much more complicated. Accordingly, the number of connections is disproportionately greater. Dual consciousness is a straight line where we can only move in two directions. It will not give us an opportunity to consider and analyze any concept in detail. To do this, you need to be able to move in all directions - right, left, up, down, in and out. But

from each such step, from each new node, it is again necessary to be able to move in all these directions. And with the increase in the number of measurements, the number of such directions is only growing. It is clear that this is not possible for a person in his current state. And this impossibility blocks even the potential possibility of its development. The conclusion is that without the intervention of the true CPS, without raising the octave of the Human Brain, without forming the dodecahedral structure of the cells of consciousness, a person was doomed to degradation, even if we do not take into account the inevitable ending that was prepared for humanity by the Ebrov intervention.

Let's think about the importance for the development of the mind and consciousness of the conceptual base and the ability to assemble into a single whole what are the scattered fragments of various conceptual apparatuses. After all, the inability to speak the same language is an essential factor in the emergence of various contradictions, and these contradictions in themselves speak of the duality of thinking, its narrowness and the impossibility of combining all parts into a single whole, if only for the sole reason that the same phenomena are named and explained differently.

But each concept is just a concept when they try to contain whole phenomena, in all their complexity and versatility, in a narrow verbal form. The human Mind, enclosed within the framework of duality, is unable to grasp these objects and phenomena in full. And it is necessary for a man to have at least some judgments, otherwise he will not be able to find an interlocutor among his fellow human beings. The level of these judgments may differ, just as different groups of "brothers" differ from each other. But without communication in general, it is impossible for a Man and, in order not to lose this communication, each person begins to defend the interests of his group of fellow human beings as his own, but, at the same time, does not realize that he does not understand the true essence of objects and phenomena.

Let's recall one of the basic principles of management - "divide and conquer". To do this, it is enough to form some contradictions between different groups and warm them up as

necessary. And it has been successfully applied in any public sphere - religion, science, art, education, politics, economics.

The goal, for example, of science, is to find the truth about the laws of nature. But everyone has their own attitude to the truth. And the search for truth in the scientific community resulted in an almost endless conviction of opponents that his view of the truth is truer (we apologize for the tautology, but this is exactly the case) than his opponents. And this is instead of trying to convince each other that the truth can be one, and all contradictions are nothing more than its facets. The reason for this lies in the fact that the possibility of accepting the truth in its multifaceted essence was inaccessible to human consciousness and reason in principle, which completely satisfied the interventionist civilization.

But now the time is different and the need to form a completely different way of comprehending knowledge and a completely different way of thinking, is a vital necessity from the point of view of integrating an individual into a new civilization. And it is clear that this path cannot be passed overnight, it is clear that changing the way of thinking requires difficult and long work to change the very essence of one's Self.

Let's move a little away from philosophizing and try to understand, by concrete examples, that an object or phenomenon is inherently wider than the framework into which they have been squeezed by various definitions.

There are a lot of people striving to search and learn new things now. It is clear that "many" is still only a few percent with a stretch, and a significant part of them have a craving for knowledge in a very specific area - esotericism. But even these "many" often cling to the level achieved, to the knowledge gained, like a kid in a sandbox with a favorite toy. And I also want my favorite toy to be the best of all.

This is an analogy, but in many ways accurate. Very often, the acquired knowledge is perceived as the ultimate truth, and all other points of view are dismissed as heresy.

Agree - a familiar situation. Not so long ago, among the members of the FAMILY, the point of view was actively promoted **that the knowledge given by N.V. Levashov is the ultimate truth**, and if something else is accepted in addition to this knowledge, then it is anathema. And even though time is moving forward, these "brothers" who are still there.

The question then rested on the fact that, as many of them believed and believe, the knowledge of N.V. Levashov and A.M. Khatybov have nothing in common with each other. And this was argued, to a large extent, by a complete difference in the conceptual apparatus. And it turns out that again, on the basis of only one external factor, a conclusion is drawn about the whole essence of the subject. After all, the concept is nothing more than an external factor, the shell, the skin of the bulb.

Let's try to separate at least the peel from the onion to make sure that behind the external differences, in fact, we are talking about the same thing.

It is clear that the volume of material is too global to make a broad analysis of the knowledge left to us by these Great Russian Scientists, but we are able to consider certain aspects.

Let's look at the law of conservation of energy, analyzed in detail by N.V. Levashov in the book "The Inhomogeneous Universe", chapter. 2.3 "The system of matrix spaces".

"Thus, as a result of the sequential formation of spatial structures, a balanced system of distribution of matter between our matrix space and others is formed. After the completion of the formation of a Six-beam, the stable state of which is possible only with the identity between the masses of matter flowing in and out of it:

where:

*N(+)* is the central region of the matrix space closing, through which matter flows into our matrix space;

*n(-) - "ray" zones of closure with another matrix space through which matter flows out of our matrix space;* 

*i* - the number of matter forms shaping the hexahedron;


mi - the mass of matter.

The identity (2.3.4) for our entire matrix space can be written in a more convenient form:

As can be seen from this formula, the laws of the conservation of matter are not violated at any level of spatial formations. From the microcosm to the macrocosm, they are common. The unity of the laws of which follows, at least from the fact that the microcosm is the structural basis of the macrocosm. The circulation of matter in the anti-six-beam goes in the opposite direction, from the boundaries of this super-space to its center. Moreover, the curvature of the matrix space is maximal in the boundary regions and minimal in the center of this spatial formation.

The condition for the stable state of the anti-six-beam is the harmony between the matter flowing out through the central zone



of interlocking of matrix spaces and the matter synthesized in the boundary zones of interlocking (external) of this type of quantization of dimensionality....

...The condition for the balanced stability of our matrix space is the balance between the matter synthesized in the matrix space and the matter flowing out through the zones of interlocking of matrix spaces".

So, the main condition for the stable existence of the system is a balance between incoming or synthesized matter in the system and matter emanating from the system.

This provision is a reflection of the law of the conservation of energy.

But it is the same position that is directly related to such a concept as albedo. Albedo is one of the basic physical characteristics used by A.M. Khatybov.

Let's compare from A.M. Khatybov.

The Earth constantly reacts to changes in its albedo, reducing it - such as earthquakes, volcanic eruptions, and tsunamis. E = 0, that is, the sum of all energy processes occurring on Earth is equal to the sum of all energy costs that cause these processes.

**The albedo of a planet** - the integral sum of the albedo of all the atoms of the planet, including the atmosphere, and this sum must be zero. Thousands of small and medium-sized earthquakes take place on Earth every day, volcanoes can "work" for a long time, but all this does not happen at the same time and not evenly, so the albedo of the Earth has the appearance of a saw (even in a day), but an artificial change in albedo entails an increase in the "teeth" of the saw and - as a consequence - high-quality time change.


**Albedo** - not a reflective ability, but a property of changing the electric potential under the influence of a magnetic pulse and a gravitational wave. The atom has one wonderful property - the energy constant of the atom is zero, but at the same time the atom is **a gravito-magneto-electric generator**.

But this property does not apply to the wave function of an atomic generator, and since the change occurs in a jump, the difference between the accumulated electric potential and the norm (zero) is the albedo of the atom. Changing any parameter entails changing the rest of the parameters.

**And now let's correlate:** "Naturally, there are many such super-spaces in our matrix space. They create, as it were, nodes in the matrix space and "atoms" are in it. Again, the structure of the macrocosm is similar to the structure of the microcosm. This is another confirmation of their unity." (N. Levashov -"Heterogeneous Universe").

From this we can conclude that matrix spaces also have a kind of atomic structure, and, accordingly, have an energy lattice, because the existence of atomic structures without energy lattices is impossible. And as we know, the structure of the macrocosm is similar to the structure of the microcosm. However, this energy grid must have a dimension different from the dimension of the primary matter that make up this space and are in contact with this grid. Otherwise, the energy grid would interact with the primary matter in the contact zone, and its qualitative structure would change, which would inevitably lead to the destruction of the entire energy structure. The energy grid is a kind of system of cords, which are, on the one hand, communication cords, and on the other hand, are a charge conductor.

**The conclusion** that follows may seem extremely controversial, but, nevertheless, we will take the liberty to express it.



The space **can be** an artificially created contour, in which the construction of energy grids is initially laid, built on a dodecahedral (at a human acceptable level of perception) basis. **The space is initially "empty".** Along the energy grids, the space is saturated with primary matter that fill the space, flowing from the nodes of the energy structure. The material embodiment of the energy grids is made of matter that are initially different in their properties and qualities to the primary matter that flow through these grids.

**The generator of the "Psi-field" ("SvetL")** was created according to a similar principle. During its operation, the Generator **creates its own space**, which is saturated with the necessary primary matter through the nodes of energy grids built on a dodecahedral basis. The programs

embedded in the generator are linked to these nodes and determine which primary matter saturate the space created by the generator, as well as their properties and qualities. The forms of interaction of matter and the consequence of this interaction are the implementation of the Programs embedded in the psi-field Generator. This should be understood as follows - the space created by the Generator is filled with substances that already have certain properties and qualities. Accordingly, the program determines exactly how their further interaction will be carried out. The space created by the Generator has an impact and rebuilds the space in which its user is located. At the same time, it should be borne in mind that the Essence of a Human is also a space.

Of fundamental importance for the interaction of the "Psi-field" Generator with a Human Being, the user of "SvetLa", is its platform or base on which it is "attached". The design of the energy grid of the Generator's carrier determines the quality of the Generator's interaction with the user and the speed of the changes made.

The ability of the energy structure of the carrier grid to store information should be recognized as an essential fact. This makes it possible for energy-informational recording of all transformations carried out by the "SvetL" Generator. Moreover, such a medium can act as a kind of archive of the Essence's memory, however, we feel that further discussions on this subject *cannot yet be public*.

There are no inherently random processes in the Universe. Everything created, being created and happening is the essence of processes to achieve the Perfect State of comprehending the Universe itself through acquiring the perfection of Consciousness of all its constituent elements. Since these processes are not random, then, as a consequence, we can recognize the complete controllability of all given processes occurring in it.

It is clear that this conclusion, at first glance, is a clear contradiction to what N.V. Levashov describes. But, let's take into account that Levashov describes the original laws of the formation of Matter and Space, and, as a consequence, Life and Mind. But any process or phenomenon that obeys the laws of Nature can be reproduced, if there are appropriate opportunities. And, a higher-level system has the ability to reproduce processes and phenomena at the level of a lower-level System, or, in other words, a Subsystem. It is only necessary to know and understand these Laws and have the appropriate potential. On the one hand, this is confirmed by the very development of Human civilization, when science tries to put Nature at its service, trying to use its Laws, at least at the same level as it (science) understands that. It does not matter now whether she has comprehended these Laws of Nature very well, nor whether these experiments benefit the Earth and Humanity. The fact itself is important. On the other hand, the very activity of N.V. Levashov is a clear confirmation of this. The most striking and characteristic example is the White Star he created.

Let us return to the question of the law of the conservation of energy and albedo.

If the albedo of a planet *is the integral sum of the albedo of all atoms of the planet, including the atmosphere, and this sum must be equal to zero,* then it follows that this provision, although in different words, describes the law of the conservation of energy. But speaking about the planet, it is right to speak not only and not so much about the planet as a celestial body, but about the planet Earth in the fullness of this concept, of course, taking into account the action of the CPS. In this context, planet Earth is a System. And, therefore, we can assume that this provision will be true for the System of any level, both at the level of the macrocosm and microcosm.

Speaking of albedo, it is necessary to take into account the time factor in the framework of the corresponding process. These changes are not straightforward. It takes a certain amount of time to change the electric potential, which in turn is a characteristic of the wave-like structure of the process. No development can go in a straight line, this would inevitably lead to the collapse of the entire system and would endanger the existence of supersystems of the appropriate level. Moreover, such a straightforward development would just be a violation of the law of the conservation of energy, so thoroughly analyzed in the book "Heterogeneous Universe". The question of wave-like motion in the development of Systems, we will try to consider in more detail in part 2 of the article.

Next, we will touch on the question of the very nature of Matter and see if there is a fundamental difference in considering this issue in the context of New Knowledge.


... Such ingenious simplicity can only be created by developing infinite matter in infinite space in infinite time. These conditions provide a minimum of forms and their properties, but those from

which everything can be created: from stars and fields to wildlife, including intelligence and sensory organs.

This is the law of infinite perfection and creation. This is the law of the highest expediency, expressed in minimization in number and absolute universality in the properties of the building material of the Universe.

An objective study of electric, magnetic and electromagnetic fields and the idea of upward integration of the structure of the World, leads to such conclusions.

... Gravitational frequencies (brief reference).

# There are no gravitons. Gravity is a property of electric charge".

Based on the above quotes, we can conclude that there are no contradictions in the views of the cited authors on the subject of the nature of matter, and they generally adhere to the same positions, although they consider the issue from different angles, or more precisely, with

different levels of detail.

And if we continue to proceed from the same positions, that is, to take electric and magnetic particles and their interaction as the basis of matter, then we can try, from this point of view, to touch on one of the fundamental concepts of N.V. Levashov.

One of the fundamental concepts in Levashov's books is dimensionality. There is a very interesting point when it comes to dimensionality, Levashov uses very precise numbers with 5 decimal places. So, this is a precisely and clearly defined physical quantity. Levashov suggests that we figure out for ourselves the concepts that he uses. At the same time, as if by chance, he makes a footnote in the book "The Last Appeal to Humanity": Dimensionality is a set of qualitative characteristics of space.

If we assume that the fundamental basis of matter, both primary and hybrid, are electric and magnetic particles, and the possibility of interaction of matter depends on the identity of their properties and qualities, determined by the quantization coefficient of dimensionality yi, then it would be logical to assume that the concept of dimensionality, which is an expression of the properties and qualities of matter and space, one way or another, otherwise, it is connected with the interaction of electric and magnetic particles, which make up this matter and space. That is, the properties and qualities of matter directly depend on the quantitative content of these particles in matter, on their spatial location and their interaction, as well as taking into account the carrier frequency or octave. Thus, we can logically assume that *dimensionality is a* "certain" coefficient of interaction of electric and magnetic particles within a given space and *matter*. And even a slight change in this coefficient significantly changes the properties and qualities of both matter and the space in which this matter is located. And since the concept of dimensionality is applicable to matter and space at different levels of consideration, from the macrocosm to the microcosm, then dimensionality at a higher level is the total coefficient of the dimensions that make up this level of elements. "It seems incredible that any atom affects the macrospace, yet, nevertheless, it is a fact. Naturally, the influence of one atom is microscopic, however, their combined influence is the balance that balances the macrospace."

Exploring the microcosm, every observer quietly sees a big and loud sensation that our vast World is built of atoms and their combinations - molecules. These are the stars, the Earth with its oceans and rivers, grass, trees and all living beings.



And if you look into the structure of an atom, there we see only three particles: an electron, a proton and a neutron. There are also fragments of them: mesons, leptons, which live for fractions of seconds and do not affect the structure of the body. Some researchers demand to add to this triad the matter of fields. No pity. But what is this matter of fields that seems to be possible to touch, but is not given to your hands

Out of respect for its existence, we conditionally add to the named triad (electron, proton, neutron) also matter of different fields, as the basis of the building material of the World. If we now look into the stuffing of "elementary" particles and fields, then in the electron we will see a lot of tightly coupled electric particles (photons) and magnetic particles (their name has not yet been

invented by us), which together, breaking out of its bowels, create an electromagnetic field in the surrounding space - a cloud of unrelated electric and magnetic particles. This indicates that no special matter is required for the fields.

It is clear that we are all still trying to get closer to the structure of the microcosm, there is a catastrophic lack of knowledge, and therefore we left to make assumptions and versions, trying to be guided at least by logic. The world of this knowledge is absolutely vast, as well as the whole universe. And it is also clear that using the words "a certain coefficient" the authors, in fact, admit their inability to deduce something more precise and substantive from this. Even so, but we don't have anything more precise and concrete yet, which means it remains to make assumptions and try to clumsily get to the truth. But without such attempts you will never get there, and using only ready-made knowledge and not trying to go further is too boring. Even though this knowledge is truly grandiose.

It's just a little distraction. Let's return to the question of electric and magnetic particles and logically move on to the question of fields.

A.M. Khatybov introduces another component in relation to the characteristics of the types of fields - the gravitational field.

"Fields as physical structures - 3, can be conditionally called electric, magnetic, gravitational, differ in frequencies and charge properties (charge octaves 4 - 512). But let's not forget that there are no gravitational particles, and gravity is a property of electric charge.

*If the charge octave is less than 64, a rigid structure of the proton atom (matter) is formed (dense matter or matter familiar to humans).* 

If the charge octave is more than 64 (up to 512), a non-inertial mass is formed, quantized by purpose and properties. Non-inertial mass is a highly organized plasma.

But there are also gravitoelectric; gravitomagnetic; electromagnetic; gravito-electromagnetic, as well as 512 types of interactions of these fields.

**The gravito-electro-magnetic field** is generated in particular by gravito-magneto-electric generators, the properties of which the atom possesses.

But this article of ours largely touches on the issues of Consciousness and Mind. Therefore, it would be appropriate here to quote the following from the works of A.M. Khatybov:

"Every living Brain cell is **an electro-magneto-gravitational generator**, and the Brain as a whole autonomously maintains the albedo of the entire human body, creating optimal living conditions for each living cell of the body. These conditions ensure the work of the whole organism as a single system.



Each Brain cell contains information about Human development, its structure and determines the lifetime of the body's cells. Given the special role of the Brain in the formation of personality, it is necessary to have information not only about the albedo of the Brain (as a whole), but also about the albedo of all organs of the Human body."

It is clear that by definition a generator as such generates what it is intended for. Accordingly, the electro-magneto-gravitational generator generates the corresponding fields with the specified frequencies. However, the "Psi-Generator" created by N.V. Levashov **must also possess and has the characteristics of an electro-magneto-gravitational generator** in order to be able to interact with flesh cells and brain cells at the same levels of dimensionality that they possess, yet, at the same time, there is an inherent ability to increase this level of dimensionality.

*The albedo of a living cell varies* in a wide range. However, this applies to the case of normal brain functioning with the albedo of brain cells E a = 0.

A change in albedo entails not only a change in the time of the processes in the atoms that make up brain cells, but also their spatial location. With an increase in albedo relative to the norm, time is shortened, while "the hours of life are accelerated", and this acceleration can be several orders of magnitude. Due to the change in the time of atomic reactions, not only the values of the magnetic pulse, gravitational frequency and electric potential change (changes in which translate the cell to a decrease in the magnetic pulse with an increase in the gravitational frequency), but also change the reaction itself to maintain the overall energy balance.

## AND FURTHER:

Gravitational frequencies with a magnetic pulse, supported by an electric potential, having a control (life) program, will naturally use control functions on those structures that will be available in the new space. When obtaining such access and organizing management functions, it makes no sense to transfer the former cells back, since we have a ready-made control system.

## AND MORE:

**The web is an electromagnetic** (in terms of modern "horse" science) **grid** in which all life on Earth exists. **Using the grid, you can give information, remove it, change the structure of life according to the appropriate program.** 

The author's works indicate the location, purpose, dates of creation, goals and means of all 18 Life Control Systems on Earth.

The web penetrates a living cell (in fact, the living cell itself is part of the web), and any cell signal, if it is not a single one, is transmitted through the web and processed by the Control System. All actions of an individual living being are subject to a single program.


Note that the concept of "web" refers specifically to the concept of "spider", and this is one of the 18 structures of Control Systems. A Brain has been created under the web, which can "remove" and process that part of the information that is necessary for the Control System of this structure.

Let's remember this information and leave it at that for now. We will definitely return to this issue later.

Magnetic matter or magnetic particles do not yet have a special name and, as we can see, have nothing to do with gravity. Yet, magnetic particles play a huge role in the structure of matter, its properties and qualities. At the same time, it is not only metals that can have magnetic properties. With an increase in the number of magnetic particles in an electron, the properties of a magnet can acquire any materials and any substances. Another question is that it is "not so easy" to arbitrarily increase the number of magnetic particles in an electron, otherwise we would live in a completely different world. However, there are mechanisms for this. Let's look into this in more detail, because this factor will be important for us to consider the question of consciousness.

Here is a rather voluminous quote from the work of **A.A. Luchin "Physical fields: A Materialistic concept of classical physics."** 

"Nature does not like a tense state. It is necessary to set energy for this. Therefore, it tends to minimal, preferably zero, energy costs. The dynamic equilibrium of the flagellum of the magnetic field of a permanent magnet, considered above, by the forces of attraction of the internal photon field (electric field) of the magnet, can be disturbed by the action of the magnetic field of the magnet on the force flagella, for example, by centrifugal forces, which give additional force to the flagellum, and it breaks away from the magnet.

Fig. 5 shows such a device, called the axion field generator by the author.

Such a field will be a space in which the flagella of the magnetic field are located, i.e., what are called lines of force, flying or located in any bodies, freely penetrating them. Hence there is a unique opportunity to make any body (object) magnetic, it

doesn't matter if it's wood, aluminum, plasticine or water. You just need to select your speed each time for the magnetic field flagella, so that when they penetrate the body, they slowdown in it. It would be nice to twist these flagella, for example, in a spiral. Then their penetration into bodies would be difficult at great depths, and the creation of large concentrations at shallow depths would help to obtain a powerful magnetic mole in a small volume.

Moreover, in a short time, such concentrated magnetic matter is obliged to grow, to be covered with electric charges to densities, which it is better not to talk about yet."

Why have we brought this fragment here? To understand **how the device shown here can affect metals, we recommend that the reader refer to chapter 3 of the cited book.** But the description of the experiments given in the book suggests that such a construction significantly changes the capabilities of a person and his consciousness. Another question is that in this situation, a person acquired a powerful tool for influencing the surrounding space and humanity, but after all, any tool can be used both for good and for harm.

In order not to be unfounded and to allow the reader to get a more holistic impression of the possibility of this device, here is another fragment from the above-mentioned book:

"Under the influence of the radiation of the Comfort generator (as the author [6] called his axion (aka torsion) generator), the carbon stick of the Grebennikov detector rotated at an angle of up to 90 degrees.

Changing the angle of irradiation of the Grebennikov detector, D. Wilcock accidentally directed a beam of radiation at a window facing the street "... I decided to amplify the beam by cupping my hands near the Comfort generator and held them like that for about 2 seconds, and during this time a bright spherical flash appeared outside the window in the path of the beam. Three seconds later, lightning flashed. I went outside to look, and then there was a second flash at the same point. Back in the house, I turned on the Comfort generator and pointed it at the window. There was no rain or wind outside, although clouds were visible in the sky. Nothing changed in the first 10 seconds. In the next 10 seconds, a wind appeared, which blew in the direction I indicated for 20-40 seconds: the wind intensified, and a light rain began. 40-60 seconds: the rain intensified, became very strong, 60-90 seconds: the rain became unusually strong, thunderclaps were heard... I had a severe headache. I turned off the generator. In 80-90 seconds, everything stopped - no rain, no wind."

He further writes: "...In the American Association of Psychotronics, in June 2002. I conducted a demonstration... in which I translated the properties of a glass of vodka into a glass of water using an axion field. Some of those present could feel alcohol 10-15 minutes after exposure to energy."

David Wilcock also gives some results of his experiments on healing people. One of the patients showed that "... his consciousness expanded very much only after three treatments in three weeks - he remembers his dreams, clairvoyance, telepathy, foresight, etc. appeared."

Why do we need to understand these mechanisms? If we turn to the "construction" (if it is permissible to say so) of the "Psi Generator" "SvetL", then one of its **most important elements** 

will be the TORUS. Today, the TORUS is the most "acceptable adapter" that allows all transformative processes to be carried out without destruction (conversion method) between the old and the new.


But, it seems, the essential role of the TORUS in the "SvetL" generator lies precisely in increasing the magnetic component in the bodies of the User's Essence. Ultimately, when considering the physics of the process, there is an increase in the dimensionality of bodies. It is known that the "SvetL" "strengthens" thoughts. But from a physical point of view, this is due to an increase in charge density. According to A.M. Khatybov, it is known that the smarter a person is, the higher the charge density during the thought process. When a cell acquires a magnetic component at the level of a dense physical body, there is an increase in the number of magnetic particles, which leads to an increase in the charge density. This happens both at the level of the proton atom, i.e., the inertial mass, and at the level of the non-inertial mass, which contributes to the production and development of additional bodies of essence. But in order for a conductor to be able to withstand a charge with a high potential, it must have the appropriate characteristics. In relation to a Human Being, a conductor is an energy structure at a noninertial level. So, before increasing the density of the charge equivalent, it is necessary to form an energy structure that will be able to withstand such a charge. Otherwise, combustion is inevitable, which will mean the destruction of flesh cells. It is clear that here we are talking about both changing the structure of such an energy lattice, gradually transforming it from cubic to dodecahedral, and changing its qualitative structure, increasing its conductivity. Therefore, this is one of the priorities for the "SvetL" Programs.

We know that thought is material, and here we can also talk about the effect of "intention". The concept of "intention" is not scientific, but rather refers to the field of esotericism, nevertheless, it is. In other words, a thought with a higher charge density has a greater potential for realization.

An increase in the number of magnetic particles by the Essence's bodies leads to an increase in its (Essence's) energy potential. But, since people are different and not all, **even among the users of the "SvetL" Generator**s, have learned to consciously control their thoughts, some kind of blocking mechanism is needed that does not allow negative thoughts to be realized. Since such mechanisms were "laid down" by N.V. Levashov and in the process of restructuring the Brain, so that a Person who underwent such a restructuring would not be able to act to the detriment of both others and himself, **such mechanisms are embedded in the "SvetL" Generator**. That is why, probably, the basis of the development potential of the "SvetL" user *is the incessant work on the transformation of his consciousness, increasing awareness, and, as a result, the ability to control and analyze his thoughts.* 

Let's return to the consideration of the question of the Mobius strip, which we have already touched on earlier.

### Mobius strip.

"Antimatter for our universe is the native matter for the universe from which it came to ours. Therefore, the only space for which there will be no harm is this space. The only way to prevent the advance of this antimatter cyclone in our space is to return this matter to its native space. But not everything is so simple. If you just find a way to transfer antimatter to your native space, there will be a violation of the balance of spaces, which is no less a problem than the antimatter cyclone itself. Therefore, I decided to try to create a matter converter between these two spaces, which looked like a huge eight, in the center of which the matter converter of both spaces was placed. The figure eight was created by a Mobius strip formed by the curvatures of both spaces. Moving in such a curved space, any matter passing through the zero point completely disintegrated into primary matter, and after passing through it, the latter created a new matter, harmonious with another space. But the curvature of space in the form of an eight did not allow this matter to escape from the transition point, and this matter, moving along the Mobius strip of this eight, returned to the transition point and again passed through the transition point into our space and was already moving along the Mobius strip in our space. In short, antimatter was trapped."

This fragment gives us an understanding of the role that the Mobius strip plays in the construction of spaces. But this fragment allows us to touch another mystery, namely, the method of creating "shifters", i.e., the mechanism by which Nikolai Viktorovich returned the

"dark ones" to the point of evolutionary bias and leading them to a harmonious path of evolutionary development. Likely, the same mechanisms operated here. After all, the path of the evolutionary development of the Mind, whatever it may be, ("light" or "dark") is also the development of matter, the formation of certain of its qualities, from which the Essence "develops". And it was thanks to the Mobius strip that it was possible to create conditions under which matter possessing certain qualities can be, as they say, looped and brought to a converter, the principle of operation of which is described in the above fragment. And in the converter, conditions have already been laid under which matter can move into another cycle of development already with new qualities corresponding to the "bright" path of development.

Here there is another assumption, or version, if you like, related to the structure of DNA and **the mystery of the 4th codon**, which the Ebers could not solve. It seems to us that the principle of the Mobius strip is also embedded in DNA. Eights, as components of the DNA helix, are not so difficult for us to imagine. There should be no breaks at the junctions of the rings, the spirals should be connected in a single chain. Of course, the idea of DNA that we have based on official science is far from reality and its true form is different. *DNA is a double helix, the helix step corresponds to the frequency value with the value of pi = 6.* 

The question is in its connections, and this already affects the harmonious flow of matter and the functioning of all input-output connections. It is possible that some analogue of such an Ebra converter could not be recreated. As a result, the disruption of connections and, accordingly, the albedo, which led to a very short period of existence of a living cell from what is potentially possible. But, again, this is just an assumption. Although, any assumption can be a starting point in the movement towards the truth. **The main thing is to set a goal to find it.** 

And here it is important to understand what is embedded in the "Psi Generator", in addition to the functions known to us.

In nature, everything exists and develops according to uniform laws. And we must understand that the "SvetL" programs, or the Psi-Generator underlying these programs, can in no way act in contradiction with these laws. On the contrary, it was created as an embodiment of these laws, but only at a disproportionately higher level of their understanding.

We can assume that N.V. Levashov's "Psi-Generator" contained the entire experience of the development of his Essence. The potential of "SvetLa" is essentially inexhaustible, and this is due to the moment of accumulation and transformation of experience. When Fedor Dmitrievich Shkrudnev asked Nikolai Viktorovich a question about how to correlate the effectiveness of his diagnosis and treatment directly with "SvetLa", he replied that the efficiency ratio was 96%.

And from this it follows a direct logical conclusion that "SvetL" contained the maximum of what Nikolai Viktorovich himself could. This means that his experience and development potential are embedded there. But "SvetL", unlike any mechanisms and devices known to us (although their comparison is in principle unlawful), contains its own development potential in close connection with the changes occurring on the Planet. But who said that this potential is limited by planetary changes? After all, we simply do not have the opportunity to go beyond the planetary level yet. And Levashov in this regard was not limited even by the limits of our Cosmos. And from his autobiography we know that he came (together with Svetlana) to Midgard-earth from another Cosmos and, it is clear that he did not come for nothing, but with quite specific tasks. And this means that his Essence carried knowledge about other universes, about completely different worlds and about another Cosmos. As a consequence - about Control Systems of a completely different level.

Therefore, is the "SvetL" only a health-improving "device", in the medical sense of the word, or is it something completely incommensurably more?

From our point of view, it is necessary to understand the issues related to health improvement in more detail. More precisely, this is not a question of recovery, but of Human Integration into a future Intelligent Civilization.

Integration is impossible without a gradual but mandatory increase in the Brain octaves. But what does it mean to increase the octave in the physical understanding of this process. As the octave of existence increases, the space of existence also changes.

Let's give an example: The cat "Behemoth" (Bulgakov, "The Master and Margarita") had a brain corresponding to the 87th octave, and there was a power of 12.8428 v/m3, in the 63rd octave it did not exist, it was an ordinary "drummer". That is, as the octave of existence increases, the space of existence also changes. It is impossible to raise the octave of the brain

without changing the space of existence, that is, the gravitational magnitudes must also be at the 65th octave, and this changes not only optics, but also all the previously established parameters of Celestial Mechanics.

Further, when the octave of the brain's existence increases, it is necessary to change the gravitational octaves.

The octave is directly related to the vibration of the magnetic pulse in the atom.

The octave and the corresponding frequency of energies determine the specific design of the construction of space. This frequency of beam waves, characterized by 8 parameters, determines a set of conditions necessary for the existence of a living cell in a given concrete space. The space of the current existence of Biostructures is the 64th octave (n = 64), as the lowest level for a living cell, if I may say so, at the same time it is also designated as the space code (64 code)

And let's not forget that there is another concept - the Biological Octave:

Frequency response of the brain connection of a specific biological object in the conditions of normal ratios of the main parameters of life support (type I).

Type II - the maximum frequency of metabolic processes.

What follows from this? And it follows from this that: if the house is going to be overhauled, does it make sense to paint the walls and change the wallpaper?

f there is a need, then it is necessary to strengthen the load-bearing structures in order to preserve the structure in principle, and begin to install scaffolding if major repairs are planned very soon.



Raising the octave of the Brain is impossible without raising the octaves of the flesh cells, and all this in a complex means a complete restructuring of the entire human body, and bringing it to a state where it can exist and develop in a completely changed reality. If a certain device is designed for a voltage of 220 volts, then with an increase in voltage it will simply burn

out.

It's the same with the Human body. **The cell in its current design will not be able to exist with an increase in the Brain octave**, it will simply collapse. So, without changing its parameters of existence and matching it with the parameters of the new space, further life is impossible.

Let's return here to the above quotes about the "web". Based on the above quotes, one of the main tasks is the basic restructuring of the entire load-bearing structure of electromagnetic gratings for new tasks in order to adapt it to changed conditions, from atmospheric gratings to a living cell. Without such a restructuring, the existence of a living cell and, as a consequence, a biostructure becomes impossible. The grid is the basic condition for the existence of life as such. Any conductor must provide the ability to move a charge and a magnetic pulse, and if it does not meet this task, then its very presence becomes meaningless. And since the "web" was created based on the realities of the former CS, then in the conditions of changing the space produced by the Native CS, it is necessary to coordinate all levels of spaces on Earth and complete transformation of the web. The Brain created under the web, without changing the entire structure of the grids, will be deprived of the possibility of receiving and processing incoming information and will end up in an information vacuum. And without information, there is no life, not to mention the fact that it loses the ability to receive and process signals coming from flesh cells, which also leads it, as a Control System of the biostructure, to a state of complete collapse and the inability to perform its functions. Accordingly, such a biostructure is subject to destruction, and the Brain is withdrawn.



Take a look at this photo. Even according to the knowledge that we already have, this design looks very close to a "Psi- Generator". And here we also see the TORUS (see above), the figure eight, very similar to the description of the Mobius strip, as well as the rings of the DNA helix.

This is the process of development and formation of a young star somewhere in deep space. And now let's remember again what we know about the Mobius strip. What is the potential for transformation and development of the "SvetL", if the stars are formed according to the same laws laid down in it? How many millions of functions, tasks, programs

This concludes the first part of this article.
