*Sometimes it is useful to reject all truths.*

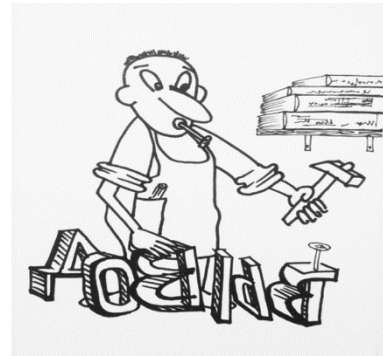
*To question that which allows no doubt.*

Consequently, logic is a **FUNDAMENTALLY UNTENABLE AND UNSUITABLE** tool for such a task. We want to think that *white is always white, and black is always black*. We subconsciously want to believe that information that casts doubt on certain truths is empty verbiage, clever talk and sophistry. Because, as Nietzsche<sup>1</sup> wrote, "*renouncing false judgments*



*would be renouncing life.*" In my view - notions of reality and illusion, I will say that our reason, logic and common sense are **NOT ABSOLUTE** and independent truths, but a consequence of the structure of the world, its nature and laws. If we had different physical laws operating in our universe, we would have different thinking and logic. But then



again, there is no logic today. It is virtually impossible to build it in the processes taking place before our eyes today. Many are trying to find it (logic), but it is not "found". There is a **REFERENCE POINT**. There is **COMMON SENSE** – it is a continuation of the laws of the world where it was born. Against this background, thinking is not independent in this sense, but only a continuation of axioms. And axioms are based on laws. **NO** truth **SURVIVES** outside of the circumstances in which it is created and in which it functions.

Why has insular England always been Russia's main ally in world wars with united continental Europe? The is(s)torians, politicians, political scientists and other "knowledgeable" people have **NO ANSWER**. Everything about relations between England and Russia is haphazard at first glance, except one thing: when Europe, united either by the Pope or Napoleon or Hitler, begins hostilities against Russia, England always opposes continental Europe along with Russia - and wins. Four times, though, England and Russia fought together, and three times they fought against each other. These days, England has left the European Union with ill-founded motivation. And in the current situation today, sided with Europe in confronting Russia's actions in Ukraine. As I write this today, however, England has already begun the process of reversing the decisions made in support of the EU and NATO actions against Russia.



***Everything concerning the relations between Russia and England is a mystery, around which there are many fantastic theories with links to documents that no one has seen.*** References are made to the kinship ties of Russian leaders and the kings of England. For example, there is a legend that Yuri Vladimirovich Dolgoruky (son of Vladimir Monomakh, Grand Duke of Kiev) was... an Englishman, because his mother Gita was the daughter of the last Anglo-Saxon king Harold II. No one has been able to confirm this for sure. References are made to the fact that Alexandra Feodorovna, the wife of Nicholas II, known as the **GERMAN PRINCESS Alice of Hesse**, was a representative of the British royal family by her education and upbringing. Her maiden name was Alice Victoria Elena Louise Beatrice, and her mother, Princess Alice, was the eldest daughter of Queen Victoria. At the age of six, she left Germany and spent most of her time in Britain, at the court of her grandmother, Queen Victoria.

It is known that King George V of England and Nicholas II resemble twin brothers because their mothers are sisters, daughters of the Danish King Christian IX. Therefore, the young Prince William of Wales (1914) is a direct descendant of the Russian Tsar Nicholas I Pavlovich, who may claim the Russian throne. This frame was taken on 24 May, 1913, in Berlin, where royalty from all over Europe were invited to the wedding of Victoria Louise of Prussia, daughter of German Emperor Wilhelm II.



Inexplicably, in March 1917, Ambassador Buchanan privately inquired, at Miliukov's request, about the **POSSIBILITY** of **EMIGRATING** Nicholas II to the United Kingdom. The answer was initially positive, but as protests arose in public circles against the departure of the former Emperor and corresponding instructions were received from London, the Ambassador had to reconsider his opinion and conveyed to the new head of government, A. F. Kerensky a categorical refusal to allow Nicholas and his family to enter the British Empire until the end of the war. Conspiracy references are made to the fact that the Great Russian Revolution was a "special operation of the 'Britons'" which resulted in the **LOSS** of **STATE SOVEREIGNTY** of the Russian Empire, ending in the transfer of Sovereign Rights over the Russian Empire in favor of - George V, King of Great Britain.

It is very important to understand that the loss of state sovereignty by the Russian Empire and the rights of the House of Romanov did not come in 1917, it **BECAME UNCONDITIONAL** back in 1913, which with pomp and ritual human sacrifice during the "celebration" was noted by the Romanovs and the Vatican. 300 years of using and managing the assets and rights of the Russian Kingdom ended with the complete collapse and bankruptcy of "effective managers" – the Vatican, the Jesuits, the Germans within the House of Romanov, who at once became ordinary citizens **NOT HAVING** rights, but only obligations and debts for 300 years of plundering Russia!

It should be understood that 300 years of the rule of a motley crowd of temporary workers in the person of secret Lutherans/Catholics/Protestants under the general brand "Romanovs", clearly did not contribute to the prosperity of the heirs along the line of Rurikovich/Bikbulatovich, which naturally led to a complete leapfrog with the possible succession and restoration of the Throne of the Sovereign Russian Kingdom. Naturally, both the Vatican and Britain, who received 300-year deferrals on debts and new debts to the Russian Kingdom, tried to do everything possible to **PREVENT** the restoration of the Sovereign Russian Kingdom or a new full-fledged, sovereign Russian statehood did not arise! And here it is necessary to pay special tribute to the "sons of the covenant" - skillful moneylenders, who over 300 years have **acquired unprecedented power and influence in Russia and the world**, their activists and agents, like the Jesuits in the Middle Ages, penetrated into all spheres and strata of society and were given the opportunity and tools to sabotage any possible constructive ideas and activities in Russia. They united with the Vatican and together with the "Britons", as a result, I must say, of an outstanding and successful special operation, consisting of a whole chain of events that naturally led to the loss of state sovereignty and the rights of the Russian Kingdom. After 300 years and 5 years for the transfer of power and rights (to Russia) from the Russian Empire, the "special operation" ended with the **SECRET TRANSFER** of the Sovereign's Rights over the Russian Kingdom in favor of George V, King of Great Britain (translated as "the land of the covenant") as a result of the **BRITISH PLANNED**, in late February and early March 1917, the so-called **"February bourgeois-democratic Revolution"**. This process was objective, because the dominant brain genotype **441**, expressed mainly within the framework of the so-called "German nationality", was "replaced" by genotype **442** (expressed by "another nationality", as I wrote in article 30\_369), as part of the implementation of the development program of a total of **44** brain genotypes.

The timing of the "revolution" was chosen deliberately, before the deadline for the transfer of balance of the Russian Empire, so as **NOT** to legitimately **ESTABLISH** a full-fledged and sovereign statehood in Russia. In the generally accepted historical interpretation of these events, a "scientific and historical" justification is given for the fact that bourgeois-democratic revolutions are supposedly a historically determined pattern associated with the inevitable change of socio-economic formations due to the high development of social productive forces. In reality, such "parasitic" theories of materialism are aimed at justifying historical and sometimes anti-human "man-made" actions **CONDEMNED** by **HUMANITY** in order to camouflage the existing causal relationship between illegal actions and the adverse consequences that have occurred for entire countries and peoples. In fact, there are no historical patterns, since historical events are conditioned and are the result of an action not "historical laws", but the **RESULT** of the **ACTIONS** of living people, within the framework of the managerial development process of the entire System, one of which is the implementation of a program for the development of a total of 44 brain genotypes, namely, the beginning of the formation of a special group of performers involved in the emerging structure of the "golden billion."

Therefore, assessing the so-called February bourgeois democratic revolution of 1917, and in fact a staged anti-state coup with the aim of seizing the rights of the Sovereign Russian Kingdom, it is indicated that the mass anti-government demonstrations of Petrograd workers and soldiers of the Petrograd garrison led to the overthrow of the Russian autocracy and the creation of a Provisional government that concentrated all legislative and executive power in its hands in Russia. But this is only the upper visible and obvious part of the "iceberg." One of the first steps in preparation for this was the special **"Act of the Berlin Conference"** adopted back in 1884, (as well as the decisions of the First World Zionist Congress, held from 29 to 31 August, 1897 in Brussels, which resulted in the famous "Protocols of the Elders of Zion" (as a planned vector in the development of the 442 brain genotype, in the designation of his belonging to this "nationality"), which enshrined the principle of the so-called "effective and justified occupation", - **"Every country that has raw materials, but cannot process them effectively, should allow international concerns and syndicates to exploit their natural resources."** Which, in fact, has been implemented since the famous 1991 in Russia. It is clear that, first of all, concerns were meant that belonged either to businessmen close to the Vatican, from the City of London, or from New York Wall Street. In these plans, a large role was assigned to the seizure of the raw material base and infrastructure of Russia. However, some Russian sovereigns, apparently, **DID NOT WANT** to **HEED** the wishes of international financial and political bigwigs. The last Tsars - Emperors were more interested in building a national economy. Thus, Emperor Nicholas II issued a decree according to which foreign capital was allowed to be freely placed in Russia, but the export of raw materials and profits received in Russia was limited to 12.8 percent. That is, if you want to develop and sell our minerals, accept Russian citizenship and leave the proceeds in Russia. Doesn't this remind readers of today, as part of the decisions being made in Russia? As a result, the country had a lot of money, and then, **DESPITE ALL** the machinations of **S. Witte**<sup>2</sup> and other high-ranking British agents of influence, **Russia's rapid economic growth began**. So, the British expert Edward Thorne wrote in 1913: **"If Western countries fail to hold Russia, then by 1930 it will have no rivals. Europe and the United States will be on the knees of the commodity giant."**

It is not surprising that the Wall Street dealers, being essentially the British crypto-aristocracy in the United States, very quickly **FOUND** a **COMMON LANGUAGE** with the "Crown," having agreed on the future division of the "Russian pie" and through their henchmen in the US government, declared an unspoken, but very tough war on Russia. In December 1911, the U.S. Ambassador in St. Petersburg handed the Russian Foreign Minister a note on the termination of the treaty on trade and navigation that had existed between our countries since 1832. The American press began to persecute all Russians. Russia was called barbaric, savage, anti-Semitic, etc. Does this **REMIND** readers of anything about what is happening today?

For example, Jacob Schiff, the famous banker and owner of the Kuhn, Loeb & Company banking house, explicitly called for "bringing the vile Russia to its knees. Schiff and his Wall Street associates staked their bets **INCITING INTERNAL UNREST** in the Russian Empire, using "*revolutionaries*" from among the "*people of the Covenant.*" And huge financial flows poured into the coffers of revolutionaries of all stripes, from the Social Revolutionaries to the Bolsheviks. Schiff alone spent about \$20 million of his own money on this "holy cause." This means that the events we are investigating are **NOT** due to the **DEVELOPMENT** of social productive forces in Russia and the World, as "scholarly" historians say, but by a concrete mercenary motive connected with the liquidation of Russia as a global economic and political competitor of Britain and the United States, with the removal of Nicholas II from the throne and the seizure of the rights of the Sovereign in the Russian Kingdom by the King of Great Britain. And if more precisely - the arrival of the brain genotype **442** to all the key positions of statehood and government, in the subsequent implementation through him of the vector of the purpose of the Management System of the interventionists. In fact, the final phase of the above-mentioned "special operation" began on 2 (15) March, 1917, **WITH THE ALLEGED ABDICATION** of Tsar Nicholas II from the Russian throne in favor of his younger brother Mikhail (Grand Duke Mikhail Alexandrovich), who signed an insignificant "*Act of Non-Acceptance of the throne (and Sovereign) on 3 (16) March, 1917. The Russian Empire,*" which had already been finally and irrevocably liquidated as completely bankrupt and, as it were, "provided" a legitimate decision on the fate of the future state structure of Russia and its status depending on the decision of the Constituent Assembly, **which was controlled by the British through agents of influence.** The current situation, connected with the absence of one direct and unconditional heir to the throne of the Sovereign Russian Kingdom and with complete discord between those and the fact that the New Sovereign State had not been proclaimed either, and the right of the Sovereign has the property of continuity, was taken advantage of by King George V. of England. (cousin of Nicholas II).

He, with the help of traitors to Russia – British agents of influence led by Lvov and Milyukov on 4 (17) March, 1917, **SECRETLY OBTAINED AND FORMALIZED** the corresponding rights of the **sole Sovereign to the Russian Kingdom, as the legitimate ruler** (junior Sovereign) of parts of it. Actually, under the jurisdiction of England/In the territory of the former Russian Empire, instead of a full-fledged sovereign state, a colony was created - the **"British trading post"**! The most important factor influencing the development of events in Russia since February 1917 was the activity of the first composition of the Provisional Government headed by Prince G. E. Lviv. In accordance with its Declaration and relying on the "conquests of February," it carried out a number of quite democratic transformations. The law on freedom of assembly and unions was adopted, censorship and other repressive bodies of the Russian Empire (police, gendarmerie, penal servitude, etc.) were abolished. Instead of the police department, the Main Directorate for Militia Affairs was created. The structures and leadership of other State bodies were reorganized. A political amnesty was declared. At the same time, the arrest of Nicholas II, as well as his ministers and other representatives of the former administration, was **AUTHORIZED**.

According to the law of 8 March, 1917, the Council of Ministers and its office were renamed the Provisional Government and its Office. The Ministry of the Imperial Court and Estates was abolished. In the second half of March, a Department for Local Government Affairs were formed under the Ministry of Internal Affairs to direct the activities of the commissars of the Provisional Government. In April 1917, a government crisis arose, in May the first coalition government was formed, which was still headed by Prince G. E. Lvov<sup>3</sup>.

The new Government reorganized the State authorities. On the basis of the Labor Department of the Ministry of Trade and Industry, the Ministry of Labor and **the Ministry of Posts and Telegraphs** were created. In order to help the families of those killed and maimed in the war, the Ministry of State Charity was formed. At the end of June, an Economic Council was established under the Provisional Government to develop a "general plan for the organization of the national economy and labor," as well as the Main Economic Council "to conduct all measures by individual departments and institutions to regulate the economic life of the country." At the end of March, a special meeting was formed to prepare a law on elections to the Constituent Assembly.

<sup>3</sup> Prince **George Evgenievich Lvov** (21 (November 2 October, 1861, Dresden-7 March, 1925, Paris) was a Russian statesman and politician. First Minister - Chairman of the Provisional Government of Russia from 2 (15) March to 7 (20) July, 1917. Member of the Cadet Party (1905-1917). During the February Revolution, Emperor Nicholas II simultaneously with his abdication appointed Lviv head of the government of the Russian Republic, with the functions of head of state.

In July 1917, the second coalition government headed by A. F. Kerensky<sup>4</sup> was formed. He, as well as Deputy Minister-Chairman, Minister of Finance, Cadet N.V. Nekrasov, Minister of Internal Affairs, Socialist Revolutionary N.D. Avksentiev, Minister of Foreign Affairs M.I. Tereshchenko and Minister of Food, People's Socialist A.V. Peshekhonov joined the Defense Committee. At the beginning of August, the position of **chief Prosecutor of the Synod was abolished and the Ministry of Confessions was formed**. On 7 August, the All-Russian Commission for Elections to the Constituent Assembly (All Elections) began its work. At the end of August, the Cabinet of the Minister of War was transformed into the Military Cabinet of the Minister-President - the Supreme Commander-in-Chief. After the liquidation of the speech of General L. G. Kornilov, instead of the government "until the final formation of the Cabinet" 1 September, a Directorate of five members - A. F. Kerensky, M. I. Tereshchenko, A. M. Nikitin, General A. I. Verkhovsky and Admiral D. N. Verderevsky - was established. To resolve the issue of the composition of the government, a Democratic meeting began working in Petrograd on 14 September, which elected the **permanent Provisional Council of the Republic - the Pre-Parliament** - on 21 September. Three days later Kerensky formed a third coalition government. In the first weeks of the February Revolution, the local state institutions of tsarism were replaced by provincial, city and county commissars of the Provisional Government. Their rights were **NOT** initially regulated, and only on 25 September, 1917, the "Provisional Regulations on Provincial (regional) and County Commissars" were promulgated. Along with the Councils, elected temporary committees of public organizations were created, which included the heads of the zemstvo and city self-government bodies. Zemstvos were also established in a number of outlying regions of Russia. The overall management of the entire system of zemstvo institutions was entrusted to the **All-Russian Zemstvo Union**. By the law of 15 April, in cities with a population of more than 150 thousand people, district self-government bodies (dumas and councils) were established, whose activities were united by the council of dumas. Thus, having created the Provisional Government of Russia, then the "Directory", covered by the screen proclaimed on 1 (14) September, 1917. The Russian Republic, a band of traitors (there is no other way to say it) under the leadership of the already mentioned agents of influence: **Kerensky, Milyukov, Rodzianko, Milyukov, Guchkov, Lvov, Shulgin and "K"**, began **SECRETLY EXERCISING** the **FUNCTIONS** of the governing body of the colonial administration in the former Russian Empire, in order to **PREVENT** the re-establishment and restoration of the legitimacy of the Sovereign - The Russian Kingdom or the New Sovereign State, the inheritor of the rights and assets of the Russian Kingdom and **our other states for 7426 years**. When the general task of covert legitimization to transfer the rights of the Sovereign of the Russian Empire/Russian Kingdom from one Sovereign to another (by the fact of George V's right to ensure continuity of succession to the throne and succession of power as the junior ruler in the Russian Kingdom) **WAS DONE, the archives, documents and seals needed by the Vatican and the Brits were taken out**. The Provisional Government of Russia/"Directory" - the colonial administration in the Russian Empire from Russia - left, and secretly registered the transfer of the territory under the actual control of the Bolshevik elite, who were the same agents/sons of the "covenant." This was the actual "entrance" into the power structures of the brain genotype 442.



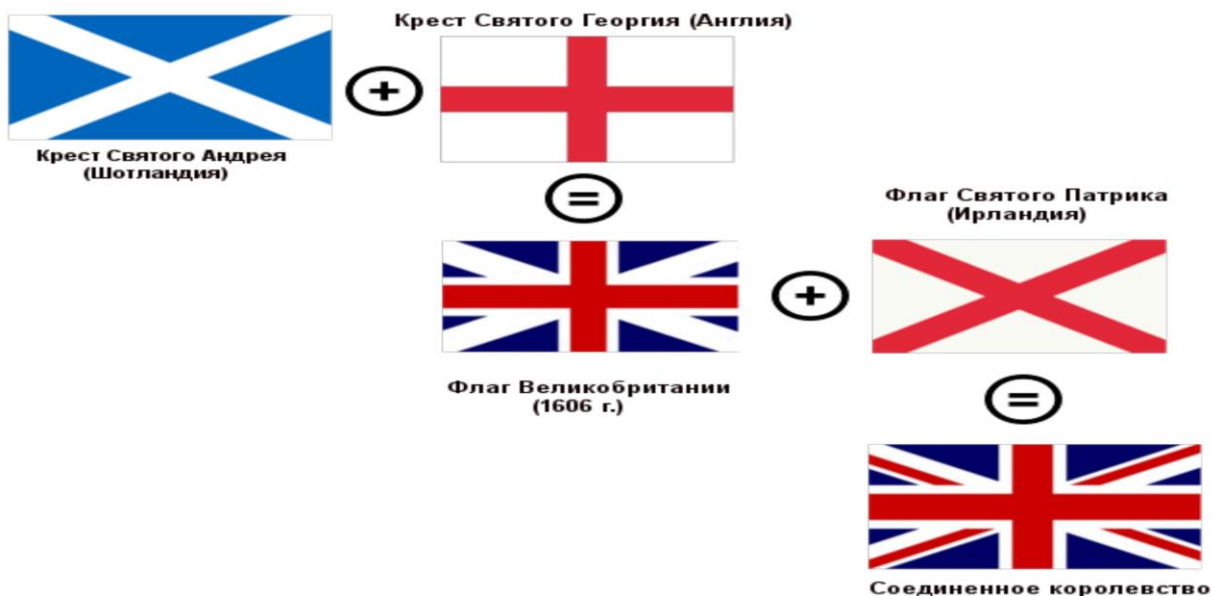
Kerensky, in contrast to the fictional historical "fact" about fleeing from the Winter Palace in a woman's dress, a few hours before the sailors broke into the Winter Palace, **LEFT** St. Petersburg with **HONOR** in a royal Rolls-Royce. At the moment when "a sailor was running, a soldier was running, shooting on the move," Kerensky was already in Pskov, at the headquarters of the Northern Front, from where he imitated the offensive of Cossack General Pyotr Krasnov on Petrograd, whose offensive was stopped by the Red Guards. The same Kerensky\Milyukov and the same agents of the "covenant" - "**Trotsky and K**" staged a revolutionary show with the Aurora shot, presenting the seizure of power (in fact, the "color revolution"), allegedly occurred as a result of the mutiny of the sailors of the Baltic Fleet. This "show" with the mutiny on the ships of the Baltic Fleet and disobedience to the naval command was carried out with a far-reaching goal and serious legal consequences. It was staged so that in the future George V on behalf of the Naval Command of the Russian Empire and within the legal framework of the same Admiral's Maritime Law (King George V of Britain had been an admiral of the Russian Fleet since 1910!!!) and at the same time , on behalf of the Sovereign over the Russian Empire , he had the legal opportunity to declare at the right time in the International Court and the High Court\The Royal London Court on the official judicial **RECOGNITION** of **ITS** Sovereign **RIGHTS to the Russian Empire**.

The operation of "cover-up" under the guise of "seizure and transfer of power to the Bolsheviks" also provided an opportunity for the royal dynasty of Great Britain to manipulate the leadership of the subjects emerging on the territory of the Russian Kingdom - the RSFSR/USSR and, if necessary, to present them at the international legal level as accomplices\heirs-successors of the "mutineers" with all the ensuing negative legal consequences to the detriment of the state sovereignty and interests of Russia. By the way, there are other documented proofs pointing to the secret transfer of Sovereign rights over the Russian Empire/The Russian Kingdom to George V. So the well-known agent of the "land of the covenant" Admiral A. Kolchak, the **SO-CALLED** "Supreme Ruler of Russia," at the investigation into the crimes committed by him, stated the following: "**On 30 December, 1917, I was accepted into the service of His Majesty the King of England!**" Thus, the so-called "February Revolution" and the October revolution of 1917 that followed it, or the "Great October Socialist Revolution," were nothing more than a "**cover operation**" of the **British king's secret seizure of the Sovereign's rights to the Russian Empire!**

According to historical data, they say, the same Kolchak described the events related to the coup of 1917 in this way: "This (i.e., the coup d'etat) was done so that in the future all subjects and authorities organized by "rebels" (that is, it is the RSFSR\USSR\CIS\The EAEU, etc.) and their accomplices were automatically considered illegal within the framework of international and Higher natural law and the rights of a true Sovereign over Russia..." And at the same time, the British monarch remained the hidden Sovereign and beneficiary of everything that Russia was and is.

So, Russia (the Russian Empire) and its people became, as it were, the subject and property of external British management, i.e., the object of management within the framework of maritime and Roman continental, commercial\corporate law, upon the fact of the absence of the transfer of balance of the Russian Empire and its acceptance by another legitimate sovereign successor entity.

Confirmation of the hidden jurisdiction and colonial dependence of the former Russian Empire and all its successors to Britain is the fact (can be regarded as material evidence in the international court) that even the colors of the flag in the Russian Empire have changed to **the colors used on the flag of its metropolis**.

That is, the black-yellow-white colors of the sovereign Russian Empire after 1913 were replaced by the current "tricolor" of the Russian Federation: - **white, blue, red, that is, the heraldic colors of the flag of the British Crown and the commercial flag of Russia** (It is not superfluous to cite as another proof the fact that in 1943 the traitor General Vlasov and his Russian Liberation Army (ROA) staged a parade in front of the Wehrmacht, where even then his "guards" marched with a flag that completely coincided with the current tricolor of the Russian Federation, i.e., with heraldic colors of the merchant fleet of the Russian Empire and the flag of Great Britain). An additional confirmation is the fact that under the Provisional Government of the Russian Empire and the "Directory," not only the flag, but also the coat of arms of Russia changed: the crowns **that previously indicated a sign of independence and sovereignty of the Russian Empire** disappeared from the heads of eagles.



Similarly, the coat of arms on the current banknotes of the Central Bank of the Russian Federation (the Central Bank of the Russian Federation and its "rubles" – as an instrument of external management of the current Russian Federation as the successor of Kerensky-Lenin-Trotsky Russia until 30 December, 1922) is also depicted with eagles without crowns, which indicates the colonial-currency dependence of the financial system of our country, as well as

the Russian Federation is a tool for managing the territory of the RC/RSFSR - the colonial administration, i.e., the "trading post." Naturally, the **TRUE PATRIOTS** of **RUSSIA**, who **grouped around Stalin, DID NOT** like such a status of the country and they tried to get rid of the **"zaslants of the land of the covenant"** by organizing a fight against the Trotskyists and other "zaslants of the covenant," carrying out major "purges" in 1937-1939. And this struggle began at the end of 1920, when Lenin and Stalin became aware that the Trotsky-Rothschild team, which actually seized control of the economy and finance in Russia in October 1917, with the help of its agents, through the People's Bank of the RSFSR (1918-1920), formed in 1918, quietly and quickly drove the RSFSR into debt and it burdened all the assets of Russia, having established by declarative means (notifying international regulators) its control over the issue of **ALL OBLIGATIONS**, debts and new and old money of Russia. This is another of the many (that exist and were waiting for us (Russia) ahead), no less "outstanding operations" against us. There is no available documentary or scientific evidence for these kind of considerations, but the fact remains that, constantly feuding and bickering with Russia, Great Britain always turns out to be its ally in wars with a united continental Europe. And Germany is always the enemy. And today England has left the European Union, and joined the confrontation of almost all of Europe with Russia, and Germany is again the leader of continental Europe. What does that mean? More than likely, after reading this material, the answer will become obvious.

From the point of view of (is) toric reflections of what is happening, there are natural patterns in the fact that periodically the countries of continental Europe unite into an Alliance, which is called something different each time, or is not named in any way, but they are fighting **AGAINST RUSSIA** with a **COMMON FRONT**. Every association of European countries is connected with the fact that from time to time they fall into a social and economic impasse, from which they emerge each time under the banner of a **NEW IDEOLOGY**, with a charismatic Pope, or Leader, or Headman, or the media at the head. It is not difficult to make sure, after reading the is(c)tory, that the technology of the united Europe's attack on Russia is always the same: **1)** in the vanguard of aggression is the ideology that gathers Europe into an Alliance (either Catholicism, the Code of Napoleon, or Hitler's "25 points"); **2)** the second echelon is the **"EXCLUSIVITY" THEORY** of European peoples; **3)** the third echelon is claims to the living space and resources of "inferior peoples";

4) the fourth echelon – a war to **DESTROY PEOPLES** who have not accepted their ideology and are disappearing from the history of Europe and from its geographical map. So all the Western European and Central European Slavs disappeared. In the table, the ideology of the three periods of European unification looks like this:

It is generally believed that the "living space" for which united Europe fought is only a physical environment in which there are all the resources necessary for life, life support: the expanses of Eastern Europe and Russia. This is absolutely true, but this environment is **UNATTAINABLE WITHOUT IDEOLOGY** – the primary idea of it, which is called the "metaphysical living space." This conceivable space is formed by its **height – the Values of life, width – the Meaning of life, length – the Purpose of life, Volume – the life force.**

Until **AN IDEOLOGY** was **FORMULATED** *from the meaning, value and purpose of life*, until then neither the Pope, nor Napoleon, nor Hitler could have an idea of the "**physical living space**" that they wanted to conquer for the life of their "citizens." This "metaphysical living space" is **CALLED** a **DREAM**. The "American dream" is known, but the same dream led sailors of European countries across the oceans in search of "physical living space" from England (James Cook, etc.), Portugal (Vasco da Gama, etc.), Spain (Columbus, etc.). The dream of a "metaphysical living space" draws a scientific Picture of the world (a map for the route to the Goal of life), a Worldview (The values of life are points of support in life's trials), a Way of life (The meaning of life to overcome one's fears), the will to live (Service beyond one's strength). ***This Dream becomes the consciousness of the people.*** The study of the history of wars between the associations of continental European countries and Russia showed that **THE IDEOLOGY** was both the Pope ("Bible"), Napoleon ("Civil Code"), and Hitler ("25 points"), as well as Alexander Nevsky (Orthodoxy), Mikhail Kutuzov (Homeland), Joseph Stalin (Marx's "Capital"). In the cases described, the ideology of Russia won. Today, Europe is going through **HARD** times again against the background of the fantastic rise of China, India, and Korea. The available physical living space has "collapsed." Europe again has to unite under the banner of the "Breton Woods Agreements" and the "Washington Consensus," armed with a liberal ideology. There is no obvious leader yet, but Napoleon, like Hitler, **SUDDENLY APPEARED** in a capacity in which they were **NOT EXPECTED**. But the events in Ukraine that are taking place today before our eyes have clearly not yet affected its appearance and will **NOT AFFECT** it a priori. Everything is happening within the framework of a New Management System and the solution of global world problems, which were **CLEARLY IDENTIFIED** with the beginning of the events in Ukraine and should be solved as one of the elements of the New World Order and a new life support system, precisely through those people (who head the participating countries of these events), or rather, through those Brain genotypes that "they will leave the iz(s)torical scene, on the "wave of their current initiative." They still have elements of an administrative and power footprint, as a former "institution of democracy," which is losing its former state of overwhelming influence on the World every day and hour. This remaining trace has now been dressed up in the form of a triune fascism: ***Financial Fascism, Administrative-bureaucratic fascism and National-demographic fascism.*** Any attempts by the belligerent West to recreate a violent Structure with its past coercive influence, aggressively manifested by hidden clan formations with the support of the NATO power bloc, are completely isolated from reality and will **NO** longer have the same **SUCCESS**. Their time is gone. It is hard for the pseudo-elite of the World to come to terms with this, so they are trying to create a distorted socionic picture of the World based on misinformation, distortion of history, ***outright lies and slander*** with the help of their pocket media. She is forced to fight with an alternative point of view, restrict freedom of speech, impose censorship, persecute dissidents, expel objectionable media. But many peoples of the planet are in **THE PROCESS** of **REALIZING** that the World is much larger than expansionist Europe, the hegemonic claims of the United States and Great Britain to the level of their "significance" claimed by them in the organized international spheres of human existence. This is an objective process, the change of which is **BEYOND** the **CONTROL** of **ANYONE** who finds

himself a direct or indirect participant in everything that is happening. All this concerns Russia directly and today requires a **SPECIFIC PUBLIC IDEOLOGY**, *an ideology that carries a real global idea that people will understand and accept, which will unite all the peoples of Russia and which, I am not afraid to say, will unite all the peoples of the World.*
