## Salvation of the Saviors (series 46-369) The Reality of the Knowledge of Faith...

Reverence without proper knowledge turns into self-torture.

Caution without proper knowledge turns into cowardice.

Bravery without proper knowledge turns into recklessness.

Straightforwardness without proper knowledge turns into rudeness.

Any faith without knowledge is an illusion.

At the beginning of research (cognition), a person always faces the question: what is the goal that I want to achieve? When the goal is determined, it is necessary to decide which road to follow and what should be taken with you. What difficulties can be encountered and in what languages will it have to be explained. But along with simple and understandable questions, questions often arise that are usually **NOT THOUGHT** about. For example, why do few people want my writings and the information that can become knowledge? This would not arise if a person thought not only about the goal, but also about the future of HIS OFFSPRING. And the future is determined in the infrastructure that a person creates on the way to achieving his goal. The end justifies the means. But by what means we are going to achieve it; it will practically be so. Seeing the target, what type of weapon would you prefer? And if without weapons, do WE NEED A TARGET? And what is needed? – How so! – some will cry out. – We are powerless before nature. Rejection of tools is tantamount to abandonment of accumulated knowledge and technological advances, tantamount to suicide! And arm themselves. To the teeth. But nature IS NOT ARMED. It only gives a person who kills life in the course of experiments, **DEAD KNOWLEDGE**. And here, as if by itself, the most accessible means arises – the rule. But if the goals are insane, then the rules are unreasonable. The purpose of most rules is to make a person a doll, a small cog – a slave of the system. Hundreds of thousands of schools have been created for this purpose. But why is there NO KNOWLEDGE of life itself? They're not there! How, how do you teach a newborn child life, if he begins life, knowing everything about it! The goal of most schools is to TAKE AWAY THE KNOWLEDGE OF LIFE, to bind a person's consciousness with false abstractions and unreasonable rules. This is what teachers in schools are doing - participants of the "game called life". Deviation from the rules is tantamount to death for them. Maybe that's why they sanctified it (the game) with high and noble concepts of the search for Truth and Goodness? There are no honest rules. Dishonest ones, too.

There ARE SIMPLY NO RULES. There is their illusion. Society has always lived and still lives on the playing field of ILLUSIONS OF RULES – the source of conflicts, the most powerful drug that zombifies a person's consciousness, cruelly controlling it, being the causative agent of mental and social disorders. The rules are a virtual opponent to whom a person does not like to lose. Today, after the change of the Control System, there are NO WIN-WIN games in society and teachers are just cogs in a game where everyone loses. They lose WITHOUT UNDERSTANDING what is happening. Understanding comes slowly today (by our human standards) for those who acquire knowledge, but most importantly, it comes. And an important condition for acquiring knowledge is the ACQUISITION of the ABILITY to distinguish between knowledge and ignorance. Modern thinkers affirmatively believe that every person, of his own free will and desire, can choose between them, take or receive in some way the part of knowledge he is interested in, and in case of dissatisfaction or uncertainty about something, fill up dissatisfaction to the level of prosperity by gaining faith, using ANY of ITS FORMS or directions, then whether in scientific dogmas, or in the religious sphere, or in some other directions oriented by it. In such a situation of states, **EXTREME** cases are **INEVITABLE**: on the one hand, a person with only acquired knowledge without the slightest signs of faith, and on the other, a person with only faith, deprived of any knowledge whatsoever.

Modern basic philosophical conclusions, as well as scientific principles, imply that there is some **OBJECTIVE KNOWLEDGE** that has passed certain experimental confirmations or generally accepted unshakable dogmatic statements that **DO NOT CONTAIN** any lies and guile, no false assumptions, false hypotheses, but also no trace of faith. They are irrefutable and



constantly replenished over time, acquired and improved exclusively by reason, logical, consistently developed and consistent. They describe in detail the whole world as a whole as civilization develops, contributing to orientation and regulation, both in the direction and in changing the pace of its development. Knowledge is understandable and accessible to everyone, easily checked and constantly used. Here is such a song, such naivety about knowledge,

sweetly sounded and today still continues to sound at the level of the power sphere that organizes all the processes of administration in the field of cognition. At the level of "gray scientific mice", by whose mind's science is directly "done", there is a **SOMEWHAT SIMPLIFIED**, different conclusion. According to their leading opinion in this case, it turns out that the knowledge of humanity is actually understood as **SOMETHING INDEFINITE**, based on the knowledge of privileged narrow groups (scientists), which other people only believe (or do not believe).

Moreover, the authority of scientists is quite often based **NOT** on the actual results of the practical manifestation or embodiment of their knowledge, but only on dogmas or associated opinions of a narrower circle of scientists, brought together in various administrative and scientific structures. From this it becomes quite sad for such an essence of knowledge. But nothing could be changed. By ensuring the provision of **DECLARED KNOWLEDGE**, the old System ensured guaranteed isolation of people from awareness of the true purpose of information, the design of its energy-informational construction, its functional, semantic and other hierarchy, true transmission, reception, control systems, and much more, which ultimately led to its next LEVEL of UNDERSTANDING, as it is still considered to be objective. In the end, all the paradigms of the modern scientific approach have led to the following associated resulting definition: information is a materialized result of conscious or nonconscious reflection by a subject of certain fragments of the real or ideal world, intended for perception by another subject. Information, as a leading BASE-FORMING TOOL, is indeed a fundamental part of all previously conducted active management of all executive processes carried out by the old System in that part of it where the MATERIAL USE of people was manifested. In this regard, it is the information that is of particular practical interest, both in terms of taking into account and understanding the features of its former constructive construction, and its **EFFECTIVE TARGETING** of individuals distinguished by brain genotypes. Correct oriented awareness in these directions will help to avoid many mistakes in understanding the events that took place, including in the field of knowledge and faith. I will present to the readers fragments, some of them, previously held by the System in absolute isolation from people's awareness, but necessary today for our judgments regarding knowledge in the hidden part of the reality that has arisen and is flowing today. This, in part, WILL HELP US **UNDERSTAND** some important aspects of the past and the essence of the material application of people in the practice of the executive processes that took place, including those concerning faith.

Faith exceeds the persuasiveness of FACTUAL OR LOGICAL evidence. And IT DOES NOT DEPEND on them, despite all the doubts or beliefs of others. The complexity and ambiguity of the phenomenon of faith has led to a variety of interpretations of its essence and functions. Faith is juxtaposed with knowledge or contrasted with it. At the same time, it is understood, first of all, as confidence in insufficiently reliable knowledge, i.e., such knowledge, the foundations of which are not given or hidden. Today it is becoming more and more obvious that this is the INFLUENCE of PROGRAM control processes, which in a very definite way DID NOT LET people go beyond the information they had already acquired and realized, DID NOT ALLOW them to realize it to the level of the true surrounding of objective reality, i.e., they were kept at the level of only the control state declared from the outside, which was required for a SPECIFIC THEMATIC EPISODE of the executed stage of actions from the general program event chronoprocess. Faith in general also applies to areas where experimental verification is generally or temporarily impossible for independent reasons and others. Then faith acts as not through verifying and thinking, but turns out to be the result of obedience and trust in authority, i.e., a certain authority, whose statements should be considered infallible and true.

However, the authorities in such instances FORM A KIND of HIERARCHY, which should end with some last and absolute instance. It no longer acts as the highest authority, but as the source of all authority and the condition of its existence as such is not discussed. God is recognized as such an authority in the religious sphere, which **CANNOT BE** considered the result of a simple extrapolation of the idea of authority. In order for an authority to be considered as such, it must act as a guide and an expression of the will of God, freely revealed to man, as authentic in itself, without reference to any other instances. Therefore, faith is inextricably linked with revelation as a free self-discovery of God in himself. Its direct impact on the "soul" of a person. Faith is correlated, first of all, with revelation as such, and not with those carriers of revelation that have a lower level, for example, codified sacred texts. Various formations organized by people in the sphere of power tried to achieve the same POSITION of the ABSOLUTE in the past. And today, in particular, the administrative formations of power structures – regarding science — are the Academy of Sciences and the Commission on Pseudoscience created in it<sup>1</sup>. In the legal field - courts and prosecutors WHO HAVE NO real relation to the justice of their actions in their practice. In the sphere of administrative power - the entire Federation Council and the executive power structure accompanying them, completely permeated with the corrupt state of imputed violence, uncontrolled compulsory dues and unpunished permissiveness, etc. This has become obvious to many today. That is why the "good intentions" of the past, inevitably DRESSED UP the RELIGIONS of their current state as an instrument of consumer use only for the governing class, contradicting the reasons and goals of their occurrence in past performance states for all, their equals.

The fate of the defining **MEANING** of **FAITH** in political life was imputed to the minds of people through the sayings of G. Hegel. He noted that "the state came from religion and now and always comes from it, i.e., the principles of the state should be considered as having force in themselves and for themselves, and this only is possible because they are recognized as definitions of the divine nature itself. Therefore, the nature of the State and its constitution are the same as the nature of religions. The state really originated from religion, and moreover in such a way that an Athenian or Roman state was possible only with a specific form of the pagan religion of these peoples, just as a Catholic state has a different spirit and a different constitution than a Protestant one."<sup>2</sup>

Here YOU CAN ADD — and what is Orthodox. "Indeed", Machiavelli also noted, "no nation has ever had a founder of extraordinary laws who would not have resorted to God, because otherwise their laws would not have been adopted." The great Florentine warned: "Just as the observance of the cult of the deity is the cause of the greatness of the states, just as the neglect of this cult is the cause of their destruction. For where there is no fear of God, it inevitably happens that the kingdom will either perish, or the fear of the sovereign makes up for the lack of religion in it." In the light of this information, it is INTERESTING to LOOK at the roots from which Christian symbols, holidays and the biography of Christ grew. Let's start with the cross. The Sumerians<sup>4</sup>, the first written civilization, use the cross to denote the mysterious planet Nibiru, orbiting the Sun in a highly elongated orbit. Once every 3500 years it passes by the Earth. They depicted her with a disk with wings (in cuneiform, a cross with details).

After the Sumerians, it is used by ancient Iranians and Hindus. They take the cross in a circle, using Mithras as a symbol of the solar deity. The outgoing sun rays forming a halo were depicted around Mithra's head. As a result of the conquests of Rome, the **CULT** of **MITHRAS** penetrates into the Roman Empire. THE ARMY and a significant part of the population become active supporters of this cult. This is how the worship of Mithra and its symbol — the cross - begins in Rome. When Rome begins the Christianization of the population, the first thing it does is put popular holiday symbols and elements of the biography of pagan deities at the service of Christianity. According to the same technology, after the collapse of the USSR, holidays and symbols were filled with new meanings. For example, 1 May turned from Workers' Solidarity Day into a holiday of spring and labor. First of all, the new religion needed ITS OWN SYMBOL. The authorities find the optimal solution - to modernize the popular symbol of the



cross, linking it with the instrument of torture and execution of Christ.

Rome turns the cross, originally a symbol of the mysterious planet Nibiru, into a **SYMBOL** of **CHRISTIANITY**. Then they deploy an operation to legalize it. A wonderful story appears about how eighty-year-old Elena (Helen), the mother of Emperor Constantine, outfitted an archeological expedition to search for the cross of the Lord. The grandmother found a certain Jew who told her (in secret) where to dig up the cross. The cross was "dug up". The question of its identification arose. The authenticity was determined in this way: a funeral procession passing by was stopped, the deceased was taken out of the coffin and attached to the cross. The dead man came to life, which meant that the cross was genuine. Then the woman took it to the capital, where a holiday was established the **FINDING** of the **CROSS**. The story of Elena, who led an archaeological expedition to find the

cross, who found a Jew who knows the secret of the cross, is **NOT** a **JOKE** invented by opponents of the Church and faith. This is the official position of the Church, spelled out in any textbook of Christianity.

Next, it was necessary to create an **OFFICIAL BIOGRAPHY** of Christ, setting out the key points. The authorities in the technology of deification and glorification find it a blessing **NOT** to **REINVENT** the wheel, but to reshape the biographies of ancient gods popular among the people in a new way. *Horus, Dionysus, Hermes were born in a stable.* The magi came to them. A star pointed the way. Mithra was born in a dungeon of stone. The shepherds were the first to worship the newborn, according to the stars. They brought him symbolic gifts — a rooster and keys. Marduk, Dionysus, Adonis were executed, buried in a rock, and then resurrected. The central element of many ancient cults is the **EXECUTION AND RESURRECTION** of the deity. The biography of Christ has absorbed all the most famous events from the life of previous deities. Christ was born in a cave. The shepherds came to



worship him first, bringing gifts. The activity of Christ repeats the techniques of the former deities. For example, at that time, the success of healing a patient strongly depended **NOT SO MUCH** on the skill of the doctor, but on the **PATIENT's FAITH** in the doctor's ability to cure him (the placebo effect).

Therefore, they were "treated" not in the way it is understood today, but *through the stretching of hands, magic words, rituals, etc.* (common methods of "healers" in today's realities). For example, Asclepius<sup>5</sup> treated his patients for blindness by anointing their eyes with saliva. Exactly the same techniques we find in Christ. They are all based on the PATIENT'S FAITH in the power of Christ. In the manner of depicting Christ (and subsequently all the saints), traces of the solar god Mithras are also clearly visible. As a halo of sun rays was depicted around the head of Mithras, so the same detail was brought into the image of Christ. Jesus is compared to the light of the rising Sun, which illuminates people who are in darkness. The service of the Church is put on the birthday of Mithra — the day of the winter solstice, from which the night begins to wane and the day to arrive. This day was perceived as the victory of life over death. At this time, mass celebrations, songs and dances were organized. The winter solstice of the ancient Egyptians was the BIRTHDAY of the god Osiris. Among the Slavic tribes — the feast of the Sun god Dazhbog or Kolyada. In Rome, this day was widely celebrated by the people as the birthday of the invincible Sun.

There is NO INFORMATION in the Bible indicating the time of Christ's birth. To eliminate the gap, the Church resorts to a proven means — in 431, the Ephesus Cathedral gathers in order to learn from the Holy Spirit the birthday of Christ. And also, how to address the mother of Christ — the *Mother of God* (who gave birth to God) or *the Mother of Christ* (who gave birth to Christ). The Church tells how the Holy Spirit revealed to the congregation that the mother of Christ should be called the Theotokos. According to Christianity, first God-Christ created his mother, and then the mother gave birth to God-Christ. How to understand this is a great mystery and inaccessible to reason. It was also revealed to the Soborians that Christ was born on the day of the winter solstice. At that time, the Roman Empire had a calendar introduced by Julius Caesar. According to this calendar, the winter solstice occurred from 24 December to 25 December. The Church declares that the day on which the birth of Mithra is celebrated is actually the birthday of Christ. And the people what... For him, a holiday, he is a holiday. For the masses, this is never the **ESSENCE**, but always the form — an excuse to have fun on a legitimate basis. Pour any content into any form, and people will celebrate. The ram does not go to the new gate. But if you paint them in the usual color, it goes like children to school. Similarly, the people: they don't care whose birthday to celebrate — Mithra or Christ. The main thing is to have fun. Subsequently, the Churches will ask questions about these amazing coincidences of episodes from the life of Christ and the myths of ancient deities. Well, what can I say here... One can only say that ALL THIS is the machinations of Satan to lead good believers astray from the true path. ALL CHRISTIAN symbols, holidays and rituals are either invented from scratch, or taken from paganism and remade to suit the situation. The people demanded a decent deception for themselves. One of the basic qualities of good looks in this case IS FAMILIARITY. There is nothing wrong with the man-made nature of rituals, symbols and holidays.

Almost all military rites are also invented. But the army did not declare the products of its "choreographers" the gift of the Holy Spirit. The Church has positioned and continues to position its products with INFORMATION from ABOVE. And since the rule "Caesar's wife is **above suspicion**" applies to her, it is impossible to suspect her of anything — a criminal offense. "Where it is impossible to ask, there is no doubt" – K. Goedel<sup>6</sup>. This ban paved the way for monstrous speculation on the red carpet. Any statements are possible because you can't ask. YOU HAVE TO BELIEVE. All this was imputed to people by the Ebrov Control System. In fairness, it must be said that the authors of the works themselves, still performed in temples, DID NOT SAY that God led them by hand. Basil the Great, Gregory the Theologian and other authors of the church service DID NOT HIDE that they invented all the rituals themselves. Naturally, not without prayer and calling for heavenly help, but these are already particulars. Martin Luther, the father of German Protestantism, significantly expanded and deepened this technology. So, in a dispute with his opponents, he wrote his statement with chalk, and if it miraculously DID **NOT DISAPPEAR** during the dispute, Luther considered it proof of his rightness. Such a powerful and indestructible proof. Omitting the "bows" and looking only at the facts, we must admit that Rome has created a unique political tool for controlling the masses — the **STATE CHURCH**, completely dependent on it. She COULDN'T make any of her decisions on her own. If traditional Christians had asked the permission of the authorities to gather, then state Christians could gather for such events **ONLY** with the **PERMISSION** of the authorities. To this day, one of the signs that the council is ecumenical is if it was convened by the will of the emperor. Such is it, state Christianity... For the sake of objectivity, I must say that the Church TRIED TO BECOME independent from the secular authorities in spiritual matters, but these attempts were always severely suppressed. For example, when St. Martin and St. Maximus the Confessor decided to assemble the Lateran Council, without the permission of the authorities, to discuss how to pray harder for the welfare of the authorities, the authorities DID NOT take this into account. She saw it as an unauthorized act—a riot. The rioters, regardless of their motives, must be punished. Parallel with modernity: in 2016, in China (in one of the provinces), people built a sculpture of Mao thirty-seven meters high with THEIR OWN MONEY. The authorities were silent all the time while it was being built. And then demolished it. The reason is that the builders **DID NOT HAVE** a permit.

It is impossible to do good deeds without the permission of the authorities. And in today's time – even more so. The reason is that the subjects **DO NOT HAVE** complete information. If they are allowed to do large-scale good without the consent of the authorities, very soon they themselves or as a result of the actions of enemies, will do something that looks good on the outside, but in fact undermines the stability of the social structure. So, people can do good on their own only within the household framework.

Good that exceeds the household level can be done only by agreement. Any attempts to evade the execution of the planned were always persecuted by the old System, quite cruelly. Equally, any attempts of conditional small-scale designation of mandatory software processes or their individual stages by small actions, or artificially reduced number of participating performers, were "not accepted" during the control as a completed result of execution. An example of true causality in the History of Christ and the Holy Trinity, which I will tell you about in the next article, is quite enough.

Attention should be paid to the fact that the more perfect the brain functions became in the process of the energy-informational dialectic of genotype development, the MORE intensive the process of cognition proceeded in terms of energy-informational density and capacity. It would seem that the more complete knowledge is, the less ignorance there should be, less doubt, and the wider the possibilities of research penetration into the secrets of the surrounding world. There should probably be a natural process of reducing such aspects, where cognition previously desperately demanded acceptance of something on faith or was forced to turn to some unprovable dogmas, i.e., naturally, the sphere of dogmatism based on faith would have to be reduced. However, IT WAS IMPOSSIBLE to hide the amazing regularity noted by both science and religion – the higher the level of knowledge of the surrounding world manifested and improved, the more people became MORE DEPENDENT on faith, despite its broad universalism in the perception of reality in the surrounding and imaginary realities. The question should naturally arise before both scientists and ministers of the religious sphere -HOW does the awareness of the unproven future or unattainable truth appear in people's minds, which is still at the stages of guesses, imaginary representations of such realities that are NOT even FELT by all five senses of people? Why do the declared dogmas, whether they are scientific, religious or any other, have such a greater effect on people than the knowledge they have acquired? It is no secret that many thinkers, both of the past and of the present time, possessing modern knowledge, were and are adherents of religious views at the same time. Why? Such an influential phenomenon is FAITH, including religious FAITH, the objects of which are God, angels, the other world, the immortality of the soul, thematic dogmas declaring the whole range of fundamental rules and issues on a particular religious denomination. The term faith today refers to the conviction based on knowledge, people's confidence in the truth of certain scientific or socio-political ideas. It does not matter for what period of time they seem to be the only appropriate and practical or inevitably applicable. The concepts of the degree of risk, truth and falsehood are closely related to the phenomenon of faith. In the unprincipled directions of being, faith begins to live an independent life in many aspects, which is quite understandable, since it receives reinforcement: the system really continues to exist, because the direction from the point of view of survival is unprincipled.

This was especially often used by the System in the processes of material application of people in software experiments on the development of the energy biogenesis of the "shirt", when the primary determinant was only the expediency of adjusting the human body, as a private secondary system, to the comfortable state needed by the Ebrov Brain. And what happened to people, what consequences it led to — all this is the old System - **NOT TAKING** into account when developing subsequent program processes.

Intellectually oriented systems, as they develop, tend to reduce the degree of uncertainty and replace faith with the necessary knowledge in all directions of their current and future existence. Beliefs play an important role in the conditional "foundation of human reality", since the initial level of "reality" consists precisely of what a person "relies on" in his life and what allows him to EXCLUDE HIS DOUBTS. From ideas or even from a system of ideas, people are able to refuse or not accept them from the very beginning. But this means that they doubt or **DO NOT BELIEVE** in them. Doubt, in turn, is an aspect of belief, and in doubt, as in belief, one abides. Doubt lives and acts according to the same laws as belief, and doubt is believed in the same way as, for example, reason. Therefore, doubt also participates in the formation of human reality created at the **CONCEPTUAL LEVEL**. If belief allows us to form such a reality as stable and unambiguous, then doubt is an UNSTABLE, ambiguous REALITY that cannot be "relied upon". This is a clash of two beliefs that destroys the stability of a conscious or fictional human reality and, consequently, confidence in it. Consequently, it is doubt that is the source of the MENTAL CONSTRUCTION of the world, and mental constructions are consciously created precisely because beliefs have left the corresponding area. The role of beliefs in human life reveals the dynamic nature of the imaginary reality in which a person lives. It is **NOT GIVEN** initially as some primordial reality, but is the fruit of the efforts and ingenuity of people who created the previous state of culture. These efforts take the form of beliefs, layered on everything that a person HAS EVER ENCOUNTERED in himself and around him, and which is a mysterious unfinished sequence of the possible and the impossible. In other words, mental constructions that have turned into beliefs form an **ESSENTIAL** PART of the legacy that the early stages of cultural development leave to the future. Which, in fact, is manifested today in all its realities. Unfortunately, the following should be noted - the concentration of all vices in people's lives today also has ITS ROOTS from the state of a specific belief, especially among the ruling class, in complete impunity and permissiveness in their actions in everything, at the same time, being mandatory in other social behavior and attitude to the rest of society. But they are still today, confident in their impunity! Belief becomes a certainty, the way of acquiring which remains unknown or hidden, but beliefs are also affected by various kinds of "national" entropy, they weaken or disappear altogether. In other words, they DO NOT EXIST by themselves. Their maintenance requires certain efforts on the part of all elements of State and any other violence. However, the content of the concept of faith IS NOT LIMITED to beliefs. Ultimately, beliefs are available for verification by referring to life experience or other demands. At the head of fascism, on the eve of the Second World War, most of them were deeply religious and cultured people, for whom fanaticism was not characteristic, but they became such in a very short period of time.

Irrepressible and "inquisitive researchers" of many scientific fields with increasing scale and intensity are making attempts to study the possibilities of the human brain. The identified effects, as a reaction to **EXTERNAL INFLUENCES**, they try to interpret in a practical perspective, solving certain target tasks of a private nature, as a rule, associated with attempts to acquire special opportunities (additional influence in managing the masses) in the interests of a **NARROW CIRCLE** from the governing estate. This is especially observed today, within the



framework of the "inflated hype regarding the so-called "artificial intelligence". Everything is used for this, WITHOUT NEGLECTING the experience accumulated over millennia, combining it with modern technical methods and techniques. Understanding the related impact features today is extremely important because modern mass media have REPEATEDLY STRENGTHENED the ways of influencing people's

consciousness that have existed for thousands of years. In this important part of management, a significant place is given to the impact on the state of faith in all its aspects of people's awareness of the surrounding reality, without neglecting religious, scientific and any other sphere of the organization of a comprehensive controlled existence of people. Faith today in the religious sphere has COMPLETELY DIFFERENT fundamental functional endowments. First of all, it is fundamentally apophatic, i.e., it is never inaccessible and necessarily conservative with its unshakable basic primary truth. The reason is that the SCIENTIFIC SPHERE, despite the depth of knowledge of the world, COULD NOT reasonably and convincingly express the goals of human existence, the true diversity of functional endowments of their brain and the existence of reason in nature, as an independent part of reality from people! Religious faith has taken over and FILLED this wasteland, replacing the weakness of science in this for a long historical period. The fundamental primacy and purposeful stability of dogmas in all religious confessions, without even bothering to explain it, consists in formulating such a goal, introducing through the declared concepts what did not exist, but should be in demand in the surrounding and other reality and, HAVING ACHIEVED CONSCRIPTION ("like a sheep flock"), to use the entire authoritative dogmatic construction as a basic basis for the organization of social, spiritual and other provisions on the structure of people's lives, having assigned to itself the functions of pastoral power management and authorized "God's command" in everything and by everyone.

Both science and religion, through their performers, **COULD NOT** foresee for themselves individually the fact that they **DO NOT JOKE** with the surrounding world, i.e., with nature, because it, as the surrounding governing reality, **DOES NOT FORGIVE** the artificially created absolute in the methods imposed on it and **INVENTED LAWS** that cannot exist outside of it, her knowledge and controlled command.

According to the current "leaders" and thinkers, the goal of a person's self-knowledge is MORE ABSTRACT than the goals of management embodied through the social constructions of people's being. The accompanied state of faith was able to give an answer only within the framework of the first goal. But a person's faith is AMBIGUOUS AND COMPREHENSIVE, because it is realized through the subjective characteristics of the individual and requires the acquisition of a certain controlled state for oneself. That is why today, the "good intentions" of the past HAVE INEVITABLY DRESSED up the religions of their CURRENT STATE as an instrument of consumer use only for the governing class, contradicting the reasons and goals of their occurrence in past performing states for everyone. The non-recognition of this fact by the governing pastoral estate leads the institution of religion to its complete destruction and precisely through the actions of its governing "elite".

Faith is a special programming state acquired together with the functional endowment of each individual at the birth of the brain, for the systemic initiation of part of its functions. It provides an unmistakable expiration of the process of awareness of the received information as the surrounding objective reality, with all subsequent performing states as a consequence. It is faith, as a program predestination, THAT PREVENTS most brain functions from systematically "making mistakes". Therefore, a person before faith, in all its widest spectrum of practical manifestation, is not happy! For some, it is a belief in scientific dogmas, and for others, in religious and political - social, perhaps in some other ones having a more simplified every day or short-term emotional-sensual character. This gives an answer to all the questions that have remained unanswered to this day, both among representatives of science and among "selected performers" from the religious sphere.

Summing up what I have written, I came to the conclusion that reality has a monolithic nature, but it is not a material monolith. It is something that is not defined by existence. It can be compared to a wall. And the drawings on the wall are all that is defined by existence.
