930 years ago, Radomir (Jesus Christ) was crucified in Jerusalem-Constantinople

On 16 February, 1086, Radomir (Jesus Christ) was crucified in Jerusalem-Constantinople. And, most likely, it is no coincidence that on the eve of the 930th anniversary of this date, one of the most notable events of recent times occurred.

The first ever meeting between the Patriarch of Moscow and All Rus' and the Pope of Rome took place on 12 February, 2016, at the Havana International Airport. It ended with the signing of a joint declaration and gave hope for the formation of a new stage in the relations between the Russian Orthodox and Roman Catholic Churches. The meeting in Cuba not only emphasized the efforts in the fight against the genocide of Christians, but, according to many analysts, will also be the beginning of the unification of all Christians.



But what is the essence of the church split into the Western (Catholic) and Eastern (Orthodox) Churches? On **16 June, 1054**, according to the Julian calendar, the papal ambassador to Constantinople, Cardinal Humberg, placed a bull with **ANATHEMA** against the Byzantine Patriarch and his followers on the altar of the Hagia Sophia. And eight days later, the council held in Constantinople condemned the papal legates and those who were in communion with them. At this council, the papal legates were condemned and anathematized in return for the fact that the latter recognized that **the Holy Spirit can also come from God the son**.

And now let's think about why the Eastern Church made such a decision. After all, so far there have been no convincing answers from the clergy on this score, as well as about the origin of Christianity itself and its eastern version.

The outstanding Russian scientist **Nikolai Morozov** noted in his book **"Christ"**, that **Christians**, in fact, **existed even before "Jesus Christ" himself**:

"Christ (χριστός) means simply: anointed, initiated, and in a special ancient sense: initiated into the mysteries of occult knowledge. At that time and in previous centuries, it was not only the "Palestinian teacher" who was called Christ, but all people who were initiated into the mysteries of the sciences of that time after a special introductory rite of anointing them with sacred oil. It follows quite naturally from this that the Christian (i.e., translated into Russian, all sorts of ordained (or priestly) sects certainly existed in the centuries preceding the evangelical "savior", as can be seen from the Hebrew Bible."

Based on obvious quotations and facts from the text of the same Bible (New Testament), the outstanding Russian scientist Nikolai Viktorovich Levashov made a very in-depth analysis of the origins of Christianity, the appearance in this world of the outstanding essence of Radomir (Jesus Christ). This deep analytical material is presented in his autobiographical work "The Mirror of my Soul" (N.V. Levashov "The Mirror of my Soul vol. 2" pp.141-188). and other works.

Christianity, as an established religion with such a name, Nikolai Levashov noted, appeared only at the beginning of the 12th century, and before that there was the so-called Greek faith associated with the cult of Dionysius. In biblical times, the **CULT of DIONYSIUS** dominated the territory of the Roman (Byzantine) Empire! Or, as it was very often called - the **Greek religion!** And after all, it was the Greek religion that Vladimir forcibly imposed on the expanses of Kievan Rus in 988 A.D. It was the Greek religion, and not the so-called Christianity. And this is quite understandable - the one who is called Jesus Christ in the New Testament was not even born then! But the cult of Dionysius itself was only another modification of the cult of Osiris, which had already been fully formed in Ancient Egypt in the XII century BC.


Thus, in the case of the **so-called Christianization of Kievan Rus**, we can talk about the transmission of **the Greek version of occult knowledge**. To this day, occult signs can be found in external church symbols (for example, in the form of the "all-seeing eye") and occult rituals can be observed (for example, communion with the "blood of the Lord").

Incidentally, the Greek-Cephal Orthodox Church (now the Russian Orthodox Church) began to be called Orthodox only in 1945.

In continuation of the theme of the initial differences between the Western and Eastern Churches, the question of the dates of Christ's birth and execution remains relevant. For example, Nikolai Levashov constantly emphasized that the one who is called Jesus Christ in the New Testament was not yet born at the time of the so-called baptism of Kievan Rus, by Prince Vladimir!

In numerous studies of the past and present by various scientists based on chronicles, astronomical and chronological data, it was noted that the birth of Christ, associated with the dating of the Star of Bethlehem (or the explosion of a supernova, the remains of which is the modern Crab Nebula

in the constellation Taurus), occurred in 1054. In some Vedic sources it is noted that Isa Kresen and others were born on this day, and other interpretations. And in the works of Nikolai and Svetlana Levashov, it is shown that this essence was **PAQOMIP/RADOMIR** (Joy of the World). Nikolai Levashov builds clear convincing evidence of the mission of Radomir (Christ), based on excerpts from the Bible (New Testament): "After all, Jesus Christ directly says that HE was SENT ONLY TO THE LOST SHEEP OF the HOUSE OF ISRAEL!" And Svetlana Levashova reveals his mission from the point of view of sacred Vedic sources:



Jesus was the son of a White Magus and our disciple, the Witch Mary. They gave birth to him in order to bring his amazing Soul to Earth.

The Magi called him to Earth to stop the "plague", which, like a spider, had long been weaving its black webs here. And it was the Magi who sent Christ to the Jews. But Jesus himself was never a Jew. The Magi hoped that he would have enough strength to stop the "black" Evil that was already spreading across the Earth. But Jesus lost by underestimating the "great weaknesses" of man... The earth was not ready for His coming, just as it was not ready for the coming of the KNOWERS.

As Nikolai Levashov has repeatedly noted, in such an extremely simple and clear explanation, the fog of lies around the name of Jesus Christ disappears, and it becomes extremely clear that he was destroyed by the

Jewish high priests in full accordance with the Torah, as a false prophet trying to take away from the "flock" of the God Yahweh his First victims - the dead sheep of the house of Israel! Jesus Christ intended to save them, but he was prevented by the faithful servants of the God Yahweh.

Nikolai Levashov focuses on those passages from the New Testament, from which it clearly follows that after Jesus Christ was crucified, there was a **TOTAL SOLAR ECLIPSE!** And at the moment when Jesus Christ expired, a rather powerful earthquake occurred: "... and the earth shook..." The writers of the New Testament and their censors were illiterate people and did not understand that such an indication allows you to calculate quite accurately both the place and time of the events described in the New Testament. And at the same time, a total solar eclipse and an earthquake make such an event unique and easily identifiable, an unrepeatable phenomenon!

Numerous researchers clearly show that there **WAS NOT** and **COULD NOT** be a total solar eclipse in 33 AD, on the site of modern Jerusalem! Nikolai Levashov noted that it is clear that the authors of the New Testament decided that by mentioning such facts as a total solar eclipse and an earthquake that occurred when Jesus Christ was dying, crucified on the cross, they would only increase religious awe among followers due to the fact that such a manifestation of nature only emphasizes the divine essence of what is happening! But we miscalculated a little! At that time, people could not yet calculate the time and place of solar eclipses, and due to their ignorance, the Biblical writers themselves left information in the New Testament that completely exposes their forgery! The fact is that, according to the chronicles and calculations of mathematicians, a total solar eclipse was in Constantinople in 1086, and according to the same chronicles, it was possible to "tie" the time of the crucifixion of Jesus Christ to Constantinople "tightly", because the total solar eclipse and earthquake were exactly in Constantinople on **16 February**, **1086**!

Then you can't help but wonder which **god-son**, from whom the **Holy Spirit** could have emanated, the Eastern (Greek) Church did not want to recognize?

The answer can be found in the materials that the outstanding Russian scientist Nikolai Morozov analyzed in his **book "Christ"**: one exceptionally talented scientist who, like all scientists of that distant period, was both an astrologer, an alchemist, a doctor, and a magician, i.e., possessed all the secrets of the then occult sciences. His name was Yeshua (in Russian, Jesus), which translated from the Ancient Syrian language means - savior. Svetlana Levashova's "Revelation" also mentions the life of the Hebrew prophet Joshua. So far, his lifetime has not been determined accurately enough. As N. Morozov noted, he preached ideas that gained him many enemies among the scientists of the old generation and several ardent supporters, of whom one, the youngest and spiritually gifted, was called John or Jonah, and the other, the eldest, Simon in Hebrew, and in Greek, as if Peter. The first, who apparently came from an intelligent family, later became a very educated man, as he wrote a highly artistic Apocalypse at that time. The second was less gifted spiritually, but very energetic and later became an outstanding practical organizer. The ideological enemies of the "rescuer" were distinguished, like all the hardened and petrified routines, by intolerance and hatred for everything outside the narrow framework of their understanding, and pronounced a death sentence on him. Nikolai Morozov, based on the Greek version of the Gospel, proved that the execution was carried out through a **pillar** (they simply put him on a stake with his hands resting on a horizontal crossbar so that the body would slide onto the stake as slowly as possible), and presented astronomical calculations, according to which this execution of the Gospel "savior" was on 20 March, 368, removal from the pillar, after the lunar eclipse, was a day later, on the morning of 21 March, and the "resurrection" was before dawn on 22 March, 368. Morozov also additionally explains that this date was even after the well-known Nicene Council, in 325, where two Christian sects, Arians and Nicolaitans, had already actively begun to confront each other (including, as is known, with a beating in the face). And the first Byzantine emperor, Constantine the Great, who made Nicolaitanism a state doctrine, was canonized by the Orthodox churches as a saint. Once again, we note that, according to Morozov, Christians existed even before "Jesus Christ", since "Christ" meant, in a special ancient sense: initiated into the mysteries of occult knowledge.




And here, again, it will be very appropriate to recall that the official date of Jesus' execution in 33 A.D., is not confirmed even remotely by any astronomical calculations, just as the date of his birth was artificially adjusted to 0 AD.

In fact, as noted in the materials of the Research Institute "TSUS", from **the year 0 (May 09!) A.D.**, a **program popularly known as "Christ"**, began to be introduced (translation into a religious and confessional methodology for ensuring governing states in the sphere of authority, i.e., religion acquired the main governing load), and frequencies for ensuring the process of **reincarnation** were introduced (the spent matrix is not thrown away, but is transferred to the next shirt. **Hence the symbolism of a mother with a baby).**

Since the entire process of managing the existence of people was prepared for the transfer of the general state of process management to **a religious and confessional methodology, for ensuring governing states** in the sphere of authority, from 0 AD, chapels, churches, mosques, Buddhist temples, began to be built on Earth in large numbers in the so-called nodes of mutual intersection of a specially created Ebrov meridian winding and parallels ("Hartman, Curie, X-ray" nodes were formed), where the potentials of the atmospheric energy grid surrounding the object, changed. In the works of A.M. Khatybov and the materials of the Research Institute of the CUS, some characteristics of such windings and nodes are given.

In addition, since that time, the process of introducing a specific state of management into the organization of people's existence, began - the "power of money", as a finally formed management program (ritually symbolized by the crucifixion of I. Christ).



Also, since **0 A.D.**, an important programmatic event has occurred, concerning the governing programmatic states of "needs, labor and work" - the division of people, both the governing and the managed estate, into two programmatic and executive levels, namely, the level of "mentals" and the level of "assignments".

As a result, from that time on, the so-called **anointed**, **initiated**, **and in a special ancient sense**, **initiated into the mysteries of occult knowledge and into the mysteries of the sciences of that time**, began to appear (according to the characteristics of Nikolai Morozov) as "Palestinian teachers", "rescuers", etc., who then began to be called Christs.

But Radomir did not fit into these program events.

Therefore, the life story of the prophet **Joshua** (the occult scientist **Yeshua** according to Morozov) was cunningly "intertwined" with the life story of Radomir, destroying the **real** biographies and putting in false ones, so that naive human minds would believe in such a "story".


It's time to distinguish



It should be noted that there are other points of view on the Star of Bethlehem, including the position of G.V. Nosovsky and A.T. Fomenko, set out in the book "THE KING OF THE SLAVS" (<u>http://www.chronologia.org/car_slav/01.html</u>). From their point of view, all events related to the dating of the birth of Jesus Christ and his crucifixion are shifted by about 100 years to the 12th century. This statement is based on references to the research of American astronomers of the 20th century, who, according to the authors, managed to "DATE PURELY ASTRONOMICALLY, and with high accuracy" this supernova explosion. The remnants of this explosion, are the modern Crab Nebula in the constellation Taurus.



What exactly are G.V. Nosovsky and A.T. Fomenko referring to? Let's quote their arguments:

Let's say right away that the date "1054" is taken from old chronicles, in particular Chinese and Japanese. Which I.S. Shklovsky completely trusts. But we have no reason to do so. Moreover, it is not at all necessary to use such dubious information. It turns out that this supernova explosion can be DATED PURELY ASTRONOMICALLY, and with high accuracy. Which is what was actually done by American astronomers in the 20th century. We will tell you about this now.

After the explosion, parts of the star fly away from the site of the catastrophe. During the first few thousand years, the speed of the dispersal of the remains of the star can be considered uniform, since space, the airless space, offers almost no resistance. And collisions with individual space objects and "dust" affect only large intervals of time. Moreover, we can only talk about the gradual deceleration of the flying "fragments". And not about their acceleration. From here follows a simple and reliable method of ABSOLUTE DATING of the explosion, that is, the flash of the star. It is necessary to measure the speed of dispersal of the "fragments" and the distance they managed to fly away. Then dividing the distance by the speed, we get the time of dispersal. Counting back the resulting time, we get the date of the explosion. Moreover, modern devices allow us to do all this with a fairly high accuracy.

So, we see that these arguments are based on the traditional Einstein propositions of modern science, about the homogeneity of outer space and the uniform velocity of objects moving in this space. But just such arguments were repeatedly and convincingly refuted by N.V. Levashov in his fundamental work "The Heterogeneous Universe", articles and speeches! And they have found numerous confirmations not only in modern research by scientists, including American ones, but were refuted during the lifetime of Albert Einstein.
