

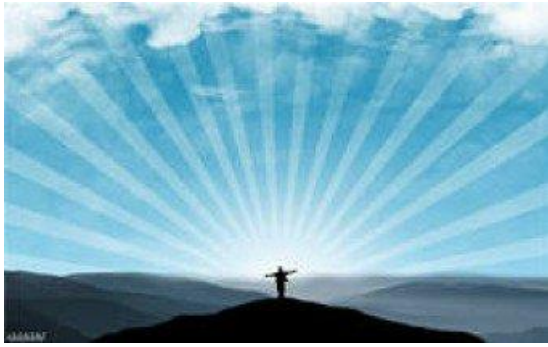
2.02. The Strategy of Human Development in the Transition Period

The future of Humanity excludes the existence of political power in the previous incarnation.



Political power, as a tool for the manifestation of imperious hegemony, an unfairly singled out minority and independently determined for themselves a preferential social position in society relative to the majority, is a complete atavism for Humanity as a society of equals, as a society of constituent functions from each and everyone. It should certainly be recognized by all figures who aspired to power in the past that it was political power in its previous incarnation that was the main source of generating social injustice, no matter what slogans it was covered with. This even applies to the period of socialism in Russia or China, since everyone personally knows and remembers the presence of "especially red party cards" from communists who fought for "equality and brotherhood of all peoples." It was the political power in all its diversity of past incarnations, whatever they were called and whatever goals they emotionally spewed out - they were the ideologists and organizers of the ultimate egoism of the whole society, achieving their preferential social position by force, using all the negativity of the violence of that time over the majority.



Under changed environmental conditions, subject to an increase in the life time of a person by almost an order of magnitude, i.e., up to 800-1000 years - it acquires incredibly high significance, as a fair incentive and as a way to find harmony between Man and Mankind. To be recognized as part of the Unstructured Power is not an honorable right to have a privileged social position. This is a well-deserved and recognized social position;

voluntary consent of the rest of the members of the social organization with such a well-deserved social position of the individual. Not to be confused with membership in any political party, since this atavism, as a parody of negative social cells, in the future also excludes the right to exist in Humanity. **There will be no more parties**, the acquisition of a parasitic special social position in an unrecognized way will be considered and recognized as a special crime against the entire social organization - Humanity.

The exclusion of political power in its previous incarnation, together with all its party attributes from the past and their past attempts and irrepressible aspirations for the power of power and the power of money, is carried out through the introduction of a social subsystem - Structureless (Public) power. It is given special functions - to be a balancing tool in the process of managing society



under the conditions of the autocracy of Structural power. I don't see I don't hear I'm silent under the conditions of the autocracy of Structural power. The Structureless government embodies its functions through representatives recognized by Humanity, whose social position is deservedly recognized by the social cells of Humanity. This completely excludes the basic basis of extreme egoism, possible attempts to revive and manifest the former false electoral systems. The recognition of the highest social position of each Person and the acquisition by him of the right to represent the whole of Humanity in Structureless Power is the highest reward and assessment of Human existence.

Due to the fact that the process already underway will be completed in the shortest possible time, namely, the elimination of foreign base octave energies of the interventional System imported from outside, together with all its docking energies (18 base octaves);

-restoration to the true state of the basic basis for the formation of spaces (**cubic to tetrahedral** and, later, to **dodecahedral**);

Serious changes are already subject to, and will be completed in the shortest possible time, changes in the basic technological foundations of combustion of all types of fuels, transformation of electricity, changed conditions for the operation of digital technologies and computing equipment, and much more.

All this will cause a direct need, in the near future, to completely change the approach and the previous understanding of the truth of values, their role and function. This, in turn, will change the material essence of the currently existing substitute for the true and reversible, as a result of which there will be a radical change in the functions of not only money, but also the entire dominant complex of financial institutions and the financial system itself. It, as an essential basis of the entire management mechanism, will undergo not only structural changes, but also functional ones. **It does not depend on the will and desire of its current organizers and managers.** Their inert auto-motor power functions will dissolve in the near future, not noticeably and not felt by them. There is no financial and economic crisis, the processes of the old Program have been completed and are no longer manageable. **Any attempts of extra-programmatic new actions to save the old one will be harshly suppressed by the System.** There is no need to provide any evidence of this, there are enough of them to this day. Let the disbeliever prove to himself, such is his fate. In a word, changes in the way and form of being as a whole will begin to manifest themselves very quickly.

By its nature, power is a social phenomenon (public) because it arises in society. **A society without power is chaos**, disorganization, self-destruction of social ties. The need for power mechanisms is due to a number of reasons, and first of all, the need to give expediency, reasonableness, organization to interactions between people by creating rules of behavior common to all. Especially in difficult conditions.

The fear of autocracy is organized, first of all, by those who themselves strive to be involved in power, i.e., to have everything and a lot immediately, but not to be invested with responsibility for the results of their rule. Liberal democracy suffers from this.

Realizing the truth of the upcoming processes of change and, accordingly, the extreme need for the concentration of managing and organizing potential, **only one option is possible - Autocracy.** Such a power can and should be determined for at least until the end of the

transition period and will be accompanied in its actions by active support from the Executors of the Conceptual Power within the framework of the new Program. **In a difficult period, only unity of command can be determined**, i.e., this is an organizational form of leadership in public administration, in which one official is **at the head of the management body, authorized by the Conceptual Authority alone to adopt legally binding management acts**. Such a person must have a legal basis at the same time. It is in this format that **Autocracy isolates society from all the weak qualities** and inability of liberal democracy to govern in the interests of society, **and will also be able and perform all the necessary functions of power in the extremely difficult situation of the transition period**.

Strategy of the Economy of Mankind for the Transitional Period.

The completion of energy structural basic transformations of the environment is coming (THIS you can observe in everyday life), which will lead to generalized changes and features at the first stage of the transition period. They will directly affect the change in the form and way of being of the entire society of the Planet.

These should include:

- changing the transformation of electricity;
- transmutation of all chemical elements with a change in atomic structure;
- changing the structure of the water grid with a complete change in its energy-informational state;
- change in the basic state of combustion technology of all currently used fuels;
- stopping the burning of gunpowder;
- changing the structure and states of radiation grids, termination of operation of nuclear power generating facilities and devices (weapons, nuclear power plants);
- **a complete change** in the established **climatic conditions** with their cardinal opposite treatment;
- **change of the entire system of the outflow of rivers and the formation of lakes, etc.**

This is not a complete list of changes, the implementation period of which is very limited, and the above is not a prediction or nonsense from the field of futurology. The consequences of these changes cannot be predicted, they should be taken for granted. Most

of them will play both a positive and a negative role in the implementation of program processes. In any case, when they are accomplished, a number of such conditions will appear that the current society has not had to meet.

Most of the population in the regions of Southeast Asia, Asia Minor and Central Asia, the Middle East and the Mediterranean zone, the region of the Scandinavian countries, in most of the territory of old Europe and North America - will be in a particularly unfavorable state in terms of people.

People will retain mostly only motor functions of the brain, extremely massive care through epidemic diseases, extremely limited controllability in the absence of awareness of the situation that is essentially occurring.

It will require an unusually large-scale operational work, a high degree of readiness and professional aptitude for making strategic unconventional management decisions. Most of the traditional means and methods of local and global management will not be acceptable. **Force support and enforcement of decisions taken will practically be reduced to zero - gunpowder, rocket and other types of fuel will not be able to burn, the bulk of the personnel of power units will not be able to fulfill their purpose, power support will not be effective.**

An indispensable condition for the correct orientation towards the goals of the future Economy within the framework of the new Program, is the realization that everything that happens in the future is inevitable and does not depend on the desire of the majority or not the desire of the minority. The entire spectrum of changes and transformations provided for by the Goal Vector will be executed and accompanied by the System.

The target framework defined by the program is based on associated conditions that will be accumulated in the near future by all changing environmental conditions.

In these difficult conditions, the main objectives of a special economic system are:

- to orient the entire system of organizing and managing actions in stages to ensure the primary necessary conditions for the survival of the remaining part of the population in the European part of the territory of Russia, with a further increase in the pace and volume of construction of a new management system in the rest of its territory, restoring and creating basic industrial potential on a new technological basis of a different level;

- to ensure the restoration on a new functional basis of all subsystems and structures of a new social instrument - **Humanity**, on a new technological basis to create a new information and cognitive environment under the control and management of Structural authorities, to pay special attention to children and youth during this period;

- to create a system for the transition to new knowledge in the field of fundamental sciences, to change the structure of education and upbringing, to organize the retraining of specialists of the entire scientific and scientific-production industry, to restore research centers and bring them to the appropriate level of knowledge, to carry out targeted reorientation and change the structure of science management;

- **to create a new financial system** in accordance with the new structure of global financial institutions, to ensure a rapid transition to a new system of value assessment;

- to carry out certification of the entire complex natural and other resource base, to organize a system of strict control over its use, replenishment and replacement;

- to create a system of safe and expedient land use. The entire territory, guaranteed to be accompanied by a life-support system, should be transferred to a position of strict control of the target application under the full responsibility of the Structural Authority;

- **to create an integrated transport system based on new principles of energy application** on a new technical and technological basis;

- **to ensure the restoration of flora and fauna** and to develop fish farming in relation to new climatic and other conditions;

- **to organize full comprehensive assistance to the remaining part of the population of other countries** with preserved and accompanied life support conditions, integrating the created social tools and subsystems into a single integrated system of Humanity.

These basic principles are taken into account in the process of organizing all managerial and managerial activities in the implementation of the strategy for building the Human Economy, which provides for two periods: the "basic" execution and the "final" execution.

Time frames of execution periods:

- the "basic" execution is carried out during the transition period (12 years) in two stages (4 and 8 years), the completion date is 2022;

- the "final" execution is carried out in the subsequent period (8 years) in one stage, the completion date is 2030.

The old program has ended, the effectiveness of all previously controlling complexes and systems has been stopped and terminated, control processes no longer have a basis for their existence due to the destruction of all aspects of their energy support to give authority

to Performers in their actions to organize events during execution. **All ties of influence and control from the outside from the Moon, Sun and satellites of the planets have been terminated**, i.e., the associated **Ebrov brain of the interventionists has been eliminated**. The entire civilized world, falling steadily into a catastrophic abyss at a steadily increasing pace, feels and recognizes that there is no natural way out of the current situation, **relying on the experience of the past, no longer exists**. All sorts of previously undertaken magical tricks and sacred techniques do not work. Something has happened that can no longer be subject to any intervention on the part of people and in general no longer depends on them and on their actions.

More so magically attracts and does not surprise with its "power" everything decisive and influencing the fictitious "world market", organized by a limited handful of gesheftmachers. Their fabulous accumulations of depreciating money can no longer so powerfully influence the methods and forms of existence of world society. The bulk of people working more out of the habit of working than out of the need to survive, listlessly contemplates this process of the dying out of everything around them and everywhere begins to excite the hum of rebellion and robbery. **This is the verdict of all the achieved results of the development of society within the framework of the established old Program. She's gone!** And the results of her achievements are no longer needed by the now emerging new world!

And what follows this verdict, what really needs to be done and, at the same time, really in an extremely short time?

First of all, it is necessary for everyone for themselves, i.e., for those who are still capable of elementary logic, to realize that it is not possible to revive all this that no longer exists.

The world has already changed, it is necessary to prepare for life in a new world. Old skills, technologies, structural and functional systems will not help to regain their former authority and adjust the functioning of society and its entire former management system to the new conditions of the changed environment.

The structural forms of management of the new System cannot accompany and give effectiveness to everything that was associated with the old states or, in any way, related to the old System. All this former conditional sufficiency to manifest itself in actions and events is dead, **and not by the will and desire of men. Independently, instead of the old Management System, people will not be able to do anything to support their existence.

They will not be able to return the entire surrounding world to its previous level, to bring its energy informational state to the old conditions, because they are alien to our planet Earth, it is freed from this.
