

The construction of organized human existence

THE PAST AND THE FUTURE OF THE PUBLIC CONSCIOUSNESS

Currently, the scientific world of social science is actively discussing the topics of problems and issues related to the formation of the world community of the future. The most problematic issue related to the ambiguity of judgments is the issue of public consciousness of the future.

In itself, the fact of the change of "System Power", as the replacement of one Control System with another ("native"), is a manifestation of a common planetary and extraplanetary scale. This entails the embodiment of all subsequent performing new actions and events within the framework of existing laws of a causal nature, arising in a single structure of the very construction of the general event chronoprocess of the development of the true Civilization of the Earth, including with the possible participation of the current society of people. By itself, the organized existence of people, as a controlled and accompanied process on the part of the System, is only a certain small part of the total existence of the entire complex of basic and derived energies on Earth, both within the limits of their material and non-material states, up to the current upper limit, i.e., 512 octaves at this current stage of the development of Civilization.

This indicated generally that very granted phenomenon and, at the same time, the predominant, but strictly identified condition of life for the planet Earth, and it is connected not only with the existence or for the sake of the existence of people! In this regard, any correction in the general management of the processes of the existence of energies on Earth leads to a significant change in the organized existence of people, in particular. And the latter, in its practical refraction, can be embodied only through an expedient change in the Design of the organized, controlled existence of people in the interests of the transition to a fundamentally new social structure – Humanity, responding to the harmony of the general processes of change taking place on Earth as a whole. Such large-scale changes, embodied now through actions and events on Earth and directly related to the very fact of involving people in them under the control of the new System, are focused on the following main directions:

-reconstruction of the former (pre-interventionist) complex harmony of the controlled being of the basic energies in its true (dodecahedral) construction, within the levels from 12 to 512 octaves inclusive, which are both in material and non-material states. Control system direction;

-elimination of the prevailing effectiveness of the basic alien (cubic) constructions of energies introduced and imputed from the outside, 18,000 years ago in the range from 15 to 128 octaves, which significantly changed previously all the truly granted nature of the material and non-material world, including the conditions of life on Earth. Constructive system direction;

-complete reanimation of the true Complexes of the Control System of the existence of the basic energies (dodecahedral structure) and the reconstruction of all the processes of development of the true substance of the Mind on Earth, including its mandatory hypostasis – the Mind of Humanity. Essential system direction;

-the re-creation of a Human by changing the complex conditions of his obligatory life support, giving him his true functions and purpose in the general process of Managing the development of the Civilization of the planet Earth, changing the level of the Brain's octaves and the corresponding provision of a different level of knowledge about the "Created World" with subsequent correction of the entire Structure of organized being – Humanity. Direction: "Penance" to the society of people for their vicious previous existence;

-reconstruction of the entire complex of control states associated with the development of a true programmatic civilization of the Earth, taking into account the mandatory proactive accelerated creation, as an integral compensation for the "lost" 18,000 years of event time. Direction: "Open (opening) The Canopy (Entrance) of the true Civilization of the Earth."

In the near future, each of the above directions will be positioned as a separate scientific, applied and spiritual sphere for practical development and implementation into the very essence of Humanity's existence through newly acquired knowledge of a completely different level. The process of providing such other knowledge is already being embodied through separate individuals by imputing information of a new energy-informational support from the recreating true System of the Earth. This process is being scaled at an increasing pace and quite progressively. As part of our research, we will pay a little more attention to the fourth, as a separately expressed direction of the ongoing changes that directly affect the practice of people's lives today. At the moment, this is demanded by the need for an imputed beginning to correct the very Structure of people's organized existence.

In fact, if, in a fundamental model framework, we imagine for ourselves a kind of conditional program algorithm for the leading directions of the changes taking place, partly directly related to people's lives as such, then all of the above makes significant corrections, and in some cases complete changes, both in the very essence of managing processes for the formation of a complex state of the Controlled environment, and the Management of changing living conditions on Earth as a whole.

This, first of all, will directly affect the issues of changing the purposeful essence of all subsequent existence on the Earth, and, in particular, the correction by functional-purpose assignment for Mankind, respectively, and the indispensable change of its organized being as such. The new existence will no longer be based on a single purposeful aspiration focused only on material goods, as the previous and current human society had.

The peculiarity of the new integrated management in general, as well as the event management of the whole changing energy, being in the framework of the new chrono-process of the Earth civilization development, is that after the change of "Systemic Power" has taken place, the very process of re-creating the states of harmony of existence must necessarily take place at an increasing pace, because there is a reasonable need for compensation for the used event time lost during the last 18,000 years.

As a consequence, soon, i.e., after achieving full perfection of harmony in all energy states of being in the entire interval up to 512 octaves, the Earth, at the command of the Supreme Governing State and the Laws of Life, will acquire a new limiting value of higher-level energy octaves, i.e., up to 1,024 octaves. This is how a peculiar qualitative transition of all states of matter in the Earth model to the next stage of its civilizational development will take place, as a controlled process by the Supreme Governing State within the hierarchy of civilizational development of planetary models with Reasonable orientation.

And these are completely different levels of all possible developing states of energies and their constructions, a different stage in the development of the Civilization of our planet as a whole. Moreover, these are fundamentally different possibilities of the material and immaterial states of energies of being, including those associated with the acquisition of new program and target conditions for the formation of a completely different organized human being at a higher level of perfection. All the changes that are taking place now, already in an obvious speculative format, demonstrate and mean the factorial threshold of a significant and essential correction in the non-man-made "Created World." True, the facts of such manifestations are positioned by current observers and their scientific supervisors far from the true understanding of the very essence of the physical processes of change. Unfortunately, such facts of changes and the apparent speculative effect of the consequences of their achievements are most often paid attention to by ministers of Religious denominations. But they also give such observed facts of changes mainly a sacral warning of meaning and character, without indulging in explanations about the true physical essence of everything that is happening around us. For the next and future generations, this will no longer be the essence of the matter.

The very essence of the future sacrament, as a state of awareness of some unattainable knowledge ("given from above") and the sacred retention of such a sacrament, will be on a completely different level, corresponding to the changed level of knowledge of any current stage of development. This will be a completely different basis for a new Faith in the future.

One of the significant fragments of everything that is happening now, namely, the resulting corrections at the current stage of event time associated with the reconstruction of the native Complexes of the Earth's Control System for the formation of a true complex existence of energies, will inevitably lead to changes in both the intensity and the very essence of energy-informational life support and, first of all, for people. This, as an inevitable consequence, will necessarily cause fundamental changes in the previously laid basis of all directions in people's worldview regarding previously established truths about the "Created World." This can be achieved only on the basis of appropriate consideration of a new higher level of knowledge provided to people by the new Control System. In turn, this will lead to a change in the resulting product in the awareness of the objective surrounding reality – a deep correction in the very essence of individual and social consciousness of people.

Currently, this process is already taking place in the most active way, but without people realizing the true essence of the revealed changes and the speculative effects of everything that is happening. So far, it manifests itself only in a conditionally conscious limited form. At the initial stage, this is expressed through a kind of auto-motor negation of all traditionally established types, forms and states of the past level of worldview, independent of people. There is a massive manifestation of internal dissatisfaction with everything that is happening.

In particular, there is dissatisfaction with the actual processes of the everyday plan and level associated with both global changes in the world around us and in finding our new comfortable place in it. There is a growing dissatisfaction with the construction of the modern social arrangement of society, organized for living people, with the collapsing states of organized existence within the framework of the norms previously established by someone, as conditionally accepted "fair" law, dictating and forming an unfair organized cohabitation for different social levels and groups, mainly based on the violence of the minority over the majority. The bulk of people who are now in a state of irreversible "non-worshipful" expression of their life position regarding their own participation in various spheres of existence organized for them, involuntarily there is a so-called "rebellion of consciousness," both individual and social.

For the present time, this is a completely natural behavioral and executive process that is beyond the will and desire of people, because the former peaceful energy-informational support from the old Control System, which previously supported the levels of world understanding with its information control broadcast at a sufficient control level of effectiveness, no longer exists.

A new process of energy-informational support from the new System is still effectively impossible for the general mass of people due to the limited level of the state of functions and the reaction of their brain (in all its three states) in the changed conditions of energy grids that comprehensively form intelligent life support, as such. Thus, so far there is no effective control effectiveness on the part of the Control System to change people's consciousness, since they can accept a new energy-informational broadcast of a cognitive nature only in a limited way, partially decrypt, broadcast, and therefore, accordingly, perceive and realize the entire reality of the change in general. That is, now the changed energy-informational essence of the surrounding objective reality is perceived only by an extremely limited group of individuals. This condition is temporary. This is precisely the important problem and the main feature of the current "man-made" traditional processes of managing the existence of people at the beginning of the Transition period, which at this hour cannot be realized by the majority, but must certainly be taken into account by the leading and externally initiated group of individuals who actually allowed it, in order to realize a number of reasons independent of them! Categorically, this fact should not be perceived as a kind of new "selectivity." Impostors, in the sense of some "as specially chosen in the past," are no longer in demand in the current and future history!!!

Although temporary, such a state for any sphere of the currently existing organized existence of people in the process of their complex traditional cohabitation, becomes very dangerous, regardless of what state affiliation they consider themselves to be or what religious denomination they relate to. This has already happened and it should certainly be realized that this has happened on the territory of the entire planet and in all societies. Such a state of societies is not yet manifested in the same degree of "rebellious effectiveness of their disobedience" in front of all previous management structures and socially unfair life patterns in society, i.e., they are manifested so far only in a speculatively passive rebellious form. But that's just for now!

Even this initial state makes itself felt and is quite significant in various societies. The emerging separate pockets of active disorganized protests against state forms of violence are not even the beginning of a future difficult state of confusion on a global scale.

Even such a focal manifestation of it can no longer be subdued by simple traditional administrative-forceful methods, since the peculiarity of the current event time, as well as the unstable transitional state of consciousness and the state of the will of the masses of the people are completely different. In the near future, we will all witness the speculative fact of the end of the collapse of Civilizations of the "capitalist and communist" types, as a completely irreversible process that is not controlled by people. Irrepressible dreamers should be warned in advance about the insolvency of their insane thoughts associated with attempts to impose on societies the imputation of some post-democratic or liberal-democratic basis in the Construction of the social order, since there are none now and, especially, in the future.

How to solve this most important problem, to give maximum peace to relations between people in such a difficult transition period? Any initiative in actions that are outside the Goal Vector of future phenomena, actions and events, regardless of the scale of the groups of people involved in modern performance processes, can suddenly lead to a catastrophe in the whole society.

This question should be correlated not only to a scientific problem, but to consider it particularly vital, comparing the problem of human survival on Earth. Any executive participation of people in future evolutionary processes through their new organized being will essentially depend precisely on the expediently acquired level and essence of the new social consciousness and, at the same time, putting it in harmony with the true essence of all the common processes of energy of the being, as such, and their management on planet Earth.

Only the harmony of people's social consciousness, commensurate with its framework target and essential state regarding the truth of the whole complex of the current processes of changing the structure of the existence of energies on the planet, and at the same time, based on the basis of knowledge of a higher level of its approximation to the truth, will allow people to find a true role and a new function of an active participant in the development of another Civilization, both the planet as a whole and Humanity in particular.

On the contrary, the absence of such harmony will give a society of people a passive dying non-vital function of their final existence, followed by their irreversible liquidation, being in such a stagnant guise of their development as an unsuitable atavism and imperfection from the past interventionist Control System. If such liquidation acquires its destructive reality, then it will be accomplished in the shortest possible time outside the will and desire of people. The revealed contours of such a tragic destiny have already been demonstrated to people in the form of a so-called systemic crisis in everything, accompanied by the increasing pace of cataclysms taking place, allegedly of "natural" origin. Such liquidation will not last for decades, unfortunately, it is very short-term and executed mainly during the Transition period.

It is the newly acquired social consciousness that will be an important qualitatively assessed indicator of the level of fitness of a society of people, controlled by the new System, as an assessment of the feasibility of integrating them into the future. The achieved required level of perfection of public consciousness and the degree of its approximation to the truth is the fact of recognition of the current society as its changed appearance – Humanity! If people do not acquire such a new state of social consciousness, which is close to the truth of the "Created World," it will mean "not recognizing a society of people by Humanity."

With the help of the question of what and how is the Control System carried out to control the state of the acquired public consciousness? We will consider this question a little later when making judgments about the functions of the atmospheric layers and the Control System.

The past knowledge of the very truth of the Divine (spiritual) principle about the "Created World," artificially imputed by the old interventionist System, is presented on the religious dogmas of the Supreme equal-to-the-Apostles object perception of God (the portrait-sculptural image of the representation of the Creator, Artist) transmitted from the outside, on the one hand. On the other hand, people's knowledge of the "Created World" was imputed by the System taking into account and on the basis of a limited object perception of the surrounding reality, presented as "scientific dogmas." It was they who laid down some limited (not true) supposed laws of existence of the surrounding material world, found stable forms of worldview in the minds of people, the idea of the general picture of the World deviated from the truth. All this, of course, is subject to a thorough correction, or rather a fundamental replacement through the approximation of knowledge to the truth.

In fact, this last one may be like a "Sentence to the majority of people now living," as the Supreme just punishment for the previous vicious existence, despite their certain innocence in this and for this. The change in the state of public consciousness and the very fact of systematic control over such a change is "Penance" (trial through punishment), from the side of the recreating true Control System and its Mind. That is the only reason why one should not treat any judgments about public consciousness and understanding of its true meaning with the superficial lightness of secular perception.

So, what is social consciousness, with the help of what philosophical, theological or other scientific definitions was it previously provided for awareness and its recognition in human society? Will it be subject to any correction or will it be rejected altogether in its current state of traditional conceptual framework? How can we form and provide people with a completely different judgment and understanding of its true essence, instead of it? Does everything depend on the correction of public consciousness on the will and desire of people, if not, what can people themselves do in this case? How and with what help can we help and organize for people such an important and necessarily necessary process of changing their social consciousness into its required expedient state, since it is through its level and state that the current society of people can be recognized by Humanity or not? How to observe the clock harmony in time of the changing state of public consciousness in the already occurring conditions of the changed and improving energy-informational support of the process of cognition, how to correspond to the clock of event time within the framework of the new general chrono-process of complex evolution on Earth? Such new problematic issues of vital importance arise before people in increasing numbers. Moreover, most of them were previously unknown at all and simply did not arise in such a target orientation.

In order to illuminate this problem at a fairly modern conceptual level with respect to the generally accepted current statements by the social sciences, as well as in the interests of observing the objectivity of the logic of our judgments, it is necessary to first draw our attention through a certain annotated review to the views of thinkers of the past on this important philosophical question, namely – what is the essence of public consciousness? Does not their recognized definition of the truth seem to be a delusion, is it only the fruit of people's mental and other activities?

The history of the beginning of any ideas by past thinkers about consciousness in general, as a kind of conditional philosophical category, has its roots from blurred antiquity on the realization of the very fact of its existence, i.e., consciousness. In the course of our research using a new methodology of energy-informational dialectics of the development of brain genotypes, we were allowed to highlight with a certain concreteness the process of developing states of changing consciousness in its true origin, previously hidden from people's perception of it. Such clarity was found on the basis of the study of processes that previously took place within the framework of the Program for the Development of brain genotypes imputed on Earth, controlled by the old interventionist System. It would not be superfluous to remind also of the fact that during this entire time people were in a state of imputed position on their material application in performing actions according to the programs of the old System. At the same time, it should be noted that, unfortunately, the interventionist System did not set a special priority goal in the civilizational development of people in their interests. People and their targeted complex development for the old System were not of significant interest to our great regret!

It should be noted that the inherent obligation in the design of the human brain of all three of its simultaneous principal states by the interventionist System was forcibly preserved, namely: neutrino, antineutrino and proton. At the moment, judgments do not matter how it was carried out in the essence of the very physics of the occurrence of such a process. But it was precisely for this reason, it was simply not possible to simplify the potential capabilities of human Brain functions, since they would no longer be independently intelligent beings (humans). Equally, it was also impossible to keep the Brain in its former true format of possibilities and at the same octave level, since giving people a program-like state of guilt would not be consistent at all. By bringing the general controlled state of the brain of people of that time to the level of the minimum possible energy octaves of its material (proton) and immaterial (neutrino and antineutrino) states, as well as by substituting cubic base lattices (in the control layer - 4,200 m - +14,800 m) of energy-informational translation and brain control in the 63rd octave, – The Ebrov System gave the whole process of human existence a certain controlled state (the "Tent" period relative to type 440 objects and the entire subsequent period), proceeding further to the formation and gradual introduction of controlled states of subsequent various Brain genotypes.

This made it possible, in a relatively short historical period, to form the primary substance of its artificially imputed interventional Mind on Earth and, at the same time, to give an appropriate controlled state of the Mind of people, thereby ensuring complete "technical" isolation of the latter from pre-existing contact with the true states of the "Supreme or Universal Mind."

Thus, the true, i.e., naturally given by nature and assigned to the cosmic functions of its purpose, control from outside was replaced by the imputed illusion of the introduced control from the Ebrov System, as supposedly control from the "Artificially Imputed Supreme", but not the True Creator. The invaders could not have it any other way, because that was what their strategy for the final captivity of the Earth envisaged. This was followed by processes of "perfection" of such forms and methods of control and with such corresponding correction of states of consciousness dictated by the System, which ensured "conscious material use of people" at all stages of development of the so-called Civilization, but which had no relation to the true Civilization of Earth with its native mind program orientation. It is from this that all the incorrectness and viciousness of the presently acquired level of development of the crumbling Civilization and its corresponding vicious Construct of the organized being of people as an atavism of the past.

Since that time, and to this day, disputes continue about the essence of consciousness and the possibility of knowing it by itself. The level of the original philosophical views did not contain a strictly expressed meaning in distinguishing concepts between consciousness and the unconscious, ideal and material, and so on. Nevertheless, the social consciousness "dictated" by the past System in the process of cohabitation of people seemed to be "formed, improved" and was certainly visible and perceived as the leading basis for all the performing actions of people associated with the construction of various hand-applied Structures of their organized existence, strictly corresponding to those program-controlled installations that were gradually imputed to in the interests of their implementation of certain performance actions and events planned by the System. It all worked flawlessly, until 25 October, 1985 (the beginning of the elimination of "installation control programs" at individual complexes and facilities of the old System, a simultaneous earthquake in Israel, northern Italy and Australia). Thus, so-called history was "made"!

For the first time (approximately 500 BC), i.e., after the introduction of brain genotype 422, judgments about consciousness as a special reality, different from material phenomena, were manifested through the philosopher Parmenides. Energy-informational support of a cognitive and controlling nature, broadcast from the Kazbek Control Complex, provided such a level of understanding of the world among a certain group of individuals with such an imputed brain genotype, which allowed for the first time to really lay down the concept of consciousness as a kind of conditional immaterial reality in the most "thinking" part of society. Continuing this "tradition," Socrates, Plato and other philosophers considered various facets and sides of people's mental activity, argued about the existence of opposites between the "spiritual and material worlds." As far as the level of the "abilities" of people of that time allowed for receiving all the information of the transmitted system of energy-informational support, some ideas of the involvement of individual consciousness of people to a certain "world Mind" were actively developed in ancient philosophy. The latter was given the function of a kind of objective universal regularity, including, as it were, influencing the substance and essence of the orientation of people's very existence, the organization of their forms of cohabitation, the social structure of society, the imputation of a certain right, the makings of a methodology of values, the expression of cultural orientation, a certain spiritual principle, elements of ethics, morality, "national traditions" and so on. All this played an important speculative role on the peculiarities of the construction of the Structures of the social order of that time, the rules of cohabitation and relations between societies of people, taking into account the functional and territorial allotments imputed by the System for each individual regions for the housing of such different societies.
